Best Practices

RVAAM's Use of Best Practices

According to the Office of Justice, a "best practice" is a technique or methodology that has been demonstrated through experience and research to be proven reliable in leading to a desired result. In other words, these practices include a specific set of processes and activities that have been shown to be the most effective. A commitment to using best practices requires an agency to therefore use all the knowledge and technology at one's disposal. The term is frequently used in the fields of health care, public administration, law enforcement, social services, mental health, education, and technology.

Every year, the Roper Victim Assistance Academy of Maryland offers a diverse and comprehensive training curriculum that focuses on best practices in the field of victim services. The Academy's Executive Director, Dr. Debra Stanley and her team of faculty and staff, strategically map out every aspect of the learning process. As a recent graduate of the Academy, I can attest to the value of the training my peers and I received and believe its success is attributed to the following:

- Provides an overview and analysis of relevant data as it relates to victimization trends, an overview of victim's rights in the state of Maryland, and a critical analysis of victim advocacy throughout the criminal justice system.
- Presents a curriculum with a clear set of learning objectives, which results in graduates leaving the Academy with a baseline of knowledge and a general appreciation of the field of victim services as a whole.
- Offers easy to understand presentations and practical experience from subject matter experts. Instructors use a student-centered approach which allows for the free flow of expressions, opinions, and ideas.

- The coursework and training exercises are designed in a manner that highlight the need for collaborative and cooperative processes that enable participants to move beyond systemic flaws and in turn provide the greatest level of assistance to victims and survivors.
- The Academy staff recruit and select a set of culturally, professionally, and geographically diverse participants to maximize students' learning experiences and foster networking opportunities.
- The Academy is held at a training facility that allows students to be removed from the hustle and bustle of their professional and personal lives, thereby promoting an optimal learning experience.
- Shortly after graduation, the Academy staff conducts surveys with that year's participants to solicit their feedback on what they felt worked well and what they would like to see amended or added to future trainings, thereby always striving to keep the curriculum relevant.
- Graduates are immediately recognized as an alumni of the Academy and invited to be a part of the Victim Services Professional Network [VSPN], RVAAM's alumni organization that supports the needs of the Academy and provides professional and social networking opportunities for all of its members.
- VSPN has also promoted the use of best practices in the field of victim services by promoting advanced trainings open to alumni and other professionals; producing and distributing a quarterly newsletter, the Academy Forum, to keep alumni abreast of pressing issues in the field of victim services and sharing resources and best practices that can assist with those matters; and managing the certification process for all victim service professionals in the state of Maryland.

In sum, the Academy has consistently utilized best practices as its framework so

it can ensure all graduates not only leave the Academy well informed, but well connected with other victim service professionals in the field. VSPN then complements those efforts by providing alumni with opportunities to network with their peers and continue their professional development through additional trainings and opportunities for multiple levels of certification.

I can think of no better avenue to continue the professionalization of our field, and I hope you will encourage your colleagues to join the RVAAM and VSPN family by attending this year's Academy!

News From the Field

Everyone knows that the field of victim services is always evolving. The challenge is to find a way to keep on top of all the changes ... we're here to help!

Here's an overview of the Bills successfully passed in 2012:

* Senate Bill 175/House Bill 8 - Crimes - Electronic Communication - Harrass-ment - This bill prohibits the use of electronic communication to maliciously engage in conduct that alarms another and clarifies the term "electronic mail" to "electronic communication" and alters the definition. The bill was signed

by the Governor on April 10, 2012 and went into effect on October 1, 2012.

- * Senate Bill 291 Unemployment Insurance - Coverage - Victims of Domestic Violence - This bill prohibits the Department of Labor, Licensing, and Regulation from charging unspecified unemployment insurance benefits against the earned rating record of an employing unit and authorizes the Secretary to find a cause of voluntarily leaving employment is good cause if it is directly attributable to the individual or the individual's spouse, minor child, or parent being a victim of domestic violence. The bill was signed by the Governor on April 10, 2012 and went into effect on October 1st, 2012.
- * Senate Bill 352/House Bill 607 National Human Trafficking Resource Center Hotline Information Sign Posting Requirements This bill requires the business owner of a privately owned bus station or truck stop located in the state to post in restrooms a sign that provides information on National Human Trafficking Resource Center. This bill was signed by the Governor on May 22, 2012 and went into effect on October 1st, 2012.
- * House Bill 766 State Government Commemorative Days Crime Victims and Advocates This bill requires the Governor annually to proclaim April 3rd as Crime Victim and Advocate Commemorative Day. This bill was signed by the Governor on May 22nd, 2012, and went into effect on October 1st, 2012.
- * Senate Bill 640/House Bill 209 Public Safety Possession of Firearms Crimes Committed in Other States This bill prohibits a person from possessing a regulated firearm, rifle, or shotgun if the person was previously

convicted of an offense under the laws of another state or the United States that would constitute a crime of violence or a violation of specified provisions of law if committed in Maryland. This bill was signed by the Governor on May 2, 2012 and went into effect on October 1, 2012.

- * Senate Bill 647/House Bill 1146- Domestically Related Crimes Reporting This bill requires the court to determine, at the request of the State's Attorney, whether a crime for which a defendant is convicted or receives a probation before judgement disposition is a domestically related crime, and to enter that finding into the court record to become a part of a defendant's criminal record. This bill was signed by the Governor on May 22, 2012, and went into effect on October 1st, 2012.
- * House Bill 618- Task Force to Study Access to Individuals with Mental Illness to Regulated Firearms - This bill establishes a Task Force to Study Access of Individuals with Mental Illness to Regulated Firearms, which will be staffed by the Governor's Office of Crime Control and Prevention. The Task Force will be required to report to the Governor and the General Assembly by December 31, 2012, on whether existing law adequately protects the public, as well as the civil rights of individuals with mental illness, and make recommendations as appropriate. This bill was signed by the Governor on April 10, 2012, and went into effect on June 1st, 2012.



- * Senate Bill 899/House Bill 349- Criminal Law Misdemeanor Possession of Child Pornography Statute of Limitations This bill increases from 1 to 2 years, the period of time within which a prosecution for misdemeanor possession of child pornography must be instituted after the offense was committed. This bill was signed by the Governor on May 2, 2012, and went into effect on October 1st, 2012.
- * Senate Bill 1082/House Bill 860- Childaren in Need of Assistance and Child Abuse and Neglect Sexual Abuse Definition This bill alters the definition of "sexual abuse" for provisions of law relating to children in need of assistance, child abuse, and child neglect to include specified actions relating to human trafficking, obscene material, pornography, and prostitution. This bill was signed by the Governor on May 2, 2012, and went into effect on October 1st, 2012.
- * House Bill 1160- Family Law Interim and Temporary Peace and Protective Orders Duration This bill extends the duration of a temporary peace order or a temporary protective order under specified circumstances, such as when the court is unexpectedly closed. This bill was signed by the Governor on April 10, 2012, and went into effect on October 1st, 2012.

Here's an overview of the legislative agenda for 2013:

* Asset Forfeiture - This bill implements a procedure by which a trafficker's assets would be seized, while providing safeguards on behalf of an innocent joint owner. With the proceeds of the sales, GOCCP will administer the "Anti-Human Trafficking Fund." Human trafficking victims have a unique set of needs and very few Maryland agencies are adequately funded to address those needs. Creating this fund would help victim services and law enforcement agencies increase their capacity to serve

this population of victims and address this growing problem.

- * Akin's Law Current law allows rapists who cause a child to be conceived the same rights as other biological parents. Additionally, if a rapist-parent cannot be located the victim's name must be published in the newspaper. This legislation would create a legal process for rape victims to terminate the parental rights of rapists when a child is conceived as result of rape.
- * Committing a Crime in the Presence of a Minor This bill enhances the penalty for persons who commit a crime of violence when such persons know or should reasonably have known that a minor is within sight or hearing of the crime. The enhanced penalty affects only those defendants who have been convicted of a crime of violence with these additional circumstances.
- * Crime Victims and Witnesses Funds Court Costs This legislation is intended to increase the amount of funding that goes to the Criminal Injuries Compensation Board (CICB) and the Maryland Crime Victims Fund (MVOC). It will increase court costs imposed on defendants from \$45 to \$60 in Circuit Court, from \$35 to \$50 in District Court, and increase a District Court traffic court fee from \$3 to \$5.
- * *Strangulation* Despite the intensely personal violence that occurs when a victim experiences strangulation, an episode of strangulation may not always result in "serious physical injury" as required by the legal qualifiers of first degree assault. Unfortunately this creates a perception that strangulation is not life-threatening, and prosecutors are unable to adequately address this act with the level of seriousness it warrants. Because strangulation often delays or leaves no visible injury, abusers are often charged with second-degree assaults or incur no charges at all. Expressly categorizing strangulation as a felony first degree

- assault gives State's Attorneys and law enforcement the tools to appropriately prosecute this act.
- * Protective Orders Expansion to Include Sexual Assault and Dating Violence - The current law only affords relief available by issuance of a protective order to individuals who are married, have been married, live together, have lived together, or have a child in common. The only recourse for individuals in a dating relationship with an abuser is to obtain a peace order, which is shorter in duration and affords less relief for the victim. This legislation proposes that individuals involved in a dating relationship or a consensual or nonconsensual sexual relationship should be eligible for relief under a protective order.
