Taxes

State and Federal taxes for the years 2015-2018 were filed on behalf of Corrotoman by the Bay (CBTB) effective December 2019. The following is a status of taxes/penalties and interest resolution.

State:

Final forms to change filing status of CBTB filed 5 February 2020. Previous charges for employee withholding taxes in 2019 (\$1,632.38) have been rescinded. Previous years have been reconciled and applicable fees/penalties have been collected. There will be approximately \$72.00 in penalties and interest due for the 2019 calendar year which Rivers Accounting has agreed to reimburse.

Federal:

We received 2 notices from the IRS for 2017 payroll taxes (for late filing/non-payment). Both were submitted to Sentry Management for payment earlier this week. Rivers Accounting was contacted for reimbursement of the penalty and interest charges and have agreed to reimburse CBTB those charges.

Summary 2018 Payroll Taxes Due/Paid:

Total Due: \$363.95 Base Tax: \$238.72 Penalties/Interest: \$125.23

There are likely to be additional taxes due for years 2015, 2016, and 2018. These will be paid and addressed when received.

It was suggested by Ian Faye that we put a \$600-\$800 buffer in the budget to address these back taxes as the IRS continues to identify them. This has been accomplished.

<u>2019 Taxes</u>

At the last meeting it was suggested that a professional firm review the CBTB records and prepare the 2019 Tax returns.

ACTION: Need to have a recommendation of who to use to accomplish this task and begin to turn the required documents over to them for processing.
