ADDED TO REMOTE (ALERTS):

1. PERMISSION OF PARTICIPATE: I, parent/guardian of the above-named participant hereby acknowledge that my child is in good health and I give my approval for my child to participate in any and all Berkley Timberwolves national, regional, league/conference, association and team/squad activities, including transportation to and from the activities by a licensed driver with proof of insurance.

2. INTENT TO INFORM: I acknowledge that I am fully aware of the potential dangers of participation in any sport and I fully understand that participation in football and cheerleading may result in **SERIOUS INJURIES, PARALYSIS, PERMANENT DISABILITY AND/OR DEATH**. Furthermore, I fully acknowledge and understand that protective equipment does not prevent all participant injuries, and therefore, I do hereby waive, release, absolve, indemnify and agree to hold harmless Berkley Timberwolves and all organizers, sponsors, supervisors, participants and persons transporting the above named participants to and from activities, from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.

3. EMERGENCY MEDICAL AUTHORIZATION: I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all Berkley Timberwolves activities.

4. EQUIPMENT RESPONSIBILITY: I agree to assume full responsibility for any and all equipment/uniforms LOANED to the above named participant and I agree to promptly return, upon request, the uniform and other equipment issued to above named participant in as good condition as when received except for normal wear and tear. If I fail to adhere to this policy, I will be responsible for the replacement cost of such equipment.

All equipment/uniform for your child's play division **MUST BE RETURNED** to Coach Glen Yearling, CEO of Berkley Timberwolves, at your child's last game. If your child is unable to attend the last game, all equipment/uniform loaned to participant must be returned immediately.

If your child is dropped from team for whatever reason or your child voluntarily quits the team, all equipment/uniform must be returned to Coach Glen Yearling immediately.

5. FINANCIAL RESPONSIBILITY: I hereby stipulate that I have been advised by the Berkley Timberwolves Organization of my rights, if any, to a refund in accordance with the organization policies.

6. COMMUNICATION AND PROMOTIONAL CONSENT: As a condition of my child's participation, I hereby consent to receive communications via email and mail from Berkley Timberwolves. I understand that Berkley Timberwolves does not sell its contact lists. Furthermore, I hereby grant Berkley Timberwolves the absolute right and permission to make, reproduce, broadcast or otherwise use participant's name and likeness, any photograph, films, videos, recordings or other depictions or images in whatever form or media in connection with participation in Berkley Timberwolves throughout the universe in perpetuity and in any and all advertising and promotional materials, in any matter or media whatsoever for purposes of art, advertising, editorial, trade or promotion or any other purpose whatsoever. To the extent that any benefits accrues or may accrue to Berkley Timberwolves, I hereby and forever waive any interest in or claim to such benefits and acknowledge that Berkley Timberwolves is under no obligation to exercise any rights granted herein.

7. ADULT CODE OF CONDUCT: S1: In order to uphold the goals of Berkley Timberwolves and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardian and other adults and attendees of Berkley Timberwolves events, including but not limited to practices, competitions and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times. **S2:** Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a Berkley Timberwolves event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave Berkley Timberwolves event. The member organization may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult who commits one of the above stated offenses a second time, will be banned from any and all Berkley Timberwolves events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period. **S3:** Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all Berkley Timberwolves events for the one year from the date of offense, and their children may also be removed from any and all Berkley Timberwolves programs for that same period of time. After the ban has expired, if he individual commits another offense of the adult code of conduct, the individual will be permanently banned from any and all Berkley Timberwolves events and the individual's children may also be permanently removed from any and all Berkley Timberwolves Programs.

8.
