Backflow Update...

As you know, the HOA Board approved purchasing faux boulders to cover the backflow devices. Check out the larger rock at 104 South Temelec Circle to get an idea of what they'll look like. The boulders come in three different colors. The sample at 104 is called sandstone tan. The other two choices are riverbed brown and fieldstone gray. VOM has assured us these boulders will cover the installed backflow

devices. If you have decided to have this work done by VOM, your signed contract is now due. If you've decided to go with Randy at Plumbing Service Company. you'll need to send a check to them at 6400 Elvas Ave. Ste. A. Sacramento, CA 95819 in the amount of \$550 by August 10th. Randy needs 50 Chantarelle homeowners to contract with him to start the project.

LANDSCAPING NOTES

Welcome to your August landscape update, friends and neighbors in Chantarelle! Hope you are staying as cool as possible on these warm summer days. Fortunately, all is going well in the landscape arena here in our community. Here is the "hot off the press" news for you ...

Details About Our Chantarelle Trees

In July the two of us had the great pleasure of working with a marvelous tree consultant who has worked in the Valley of the Moon for many years. His name is John Meserve and his tree consultancy is based in Glen Ellen.

His first comment to us was about how pleased he was to observe the excellent condition of our trees. He offered the perspective that thanks to the quantity and great health of our community trees, each and every homeowner derives the benefit of increased home and property value, because well-tended mature trees add greatly to the overall beauty and desirability of a community of homes. Great news to hear from such an experienced tree consultant.

John was particularly impressed with how healthy our redwoods look. His comments regarding the redwoods also strengthened our understanding that redwoods live as a community. These native trees link roots and support each other, so that each individual tree lives in balance and has the strength it needs to thrive. That's why it is very damaging to remove an individual redwood from a grove of trees. It does increase the chances of other tree failure if we remove one.

We also learned that fortunately, trees do not need to be fertilized the way lawns and shrubs do. They draw enough nutrients, particularly nitrogen, from the soil and water to exist for their entire lifetime without supplemental fertilization, so that is really good news!

Thanks to John's recommendation, we will continue to treat our community's birch

trees on a yearly basis for the Birch Borer pest. That will ensure the longevity of these beautiful trees that create such a lovely park-like environment in front of our Clubhouse.

The ornamental pear trees that suffered a very bad infestation of fire blight two years ago still bear some dead branches from that ordeal. As John recommends, we are going to allocate enough funds from our tree-pruning budget to eliminate all the dead branches that still exist. There are so many that it has seemed beyond the scope of what we could afford, but ultimately, eliminating every one of these fire-blighted branches will help to ensure the longevity of our pear trees which bloom so beautifully in the spring and turn such gorgeous colors in the autumn.

John also confirmed our preference to allow the crepe myrtle to grow as actual trees, rather than be pruned way back to look like ice cream cones. We have already been moving our Waldron team in this direction with regard to the pruning of these lovely blooming trees, but now we have more guidance as to how to allow these trees to branch naturally into true trees in the coming years.

Moving Toward Organic Weed Management

As you may or may not already know, our Waldron team (like so many landscaping companies) has been utilizing Roundup for years to kill weeds. We have been working since the beginning of our service on the Landscape Committee to eliminate the use of this harsh chemical product in our neighborhood, but it has taken awhile to come up with a reasonable solution that keeps the weeding workload reasonable and at the same time is healthy for the ground and water.

This year we tried a white vinegar solution at the standard dilution of 5%, and so far it hasn't been entirely successful, so we are continuing to explore alternatives that are within budget and also entirely earth-friendly. Our first new alternative will be to up the amount of white vinegar to 15%, as we have heard that this concentration works more effectively. We'll see how it goes. If that doesn't work, then there are other organic weed-killing solutions, but these are more expensive.

Well, a longer than usual report from your landscape team, but hopefully this will be valuable and helpful information for us all to know.

This is an excerpt from the article "10 Scams Targeting Bank Customers":

Government "imposter" frauds: These schemes often start with a phone call, a letter, an email, a text message or a fax supposedly from a government agency, requiring an upfront payment or personal financial information, such as Social Security or bank account numbers. "They might tell you that you owe taxes or fines or that you have an unpaid debt. They might even threaten you with a lawsuit or arrest if you don't pay," said Michael Benardo. manager of the FDIC's Cyber Fraud and Financial Crimes Section. "Remember that if you provide personal information it can be used to commit fraud or be sold to identity thieves. Also, federal government agencies won't ask you to send money for prizes or unpaid loans, and they won't ask you to wire money to pay for anything."
