E. AMENDMENTS AND ADDITIONAL ARTICLES

AMEND - ARTICLE III

The specific purpose for which this corporation is organized is a non-profit religious corporation exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. West Central Florida Pagan Alliance, Inc.'s purpose is to educate the Pagan and non Pagan Public, coordinate safe spaces for worship and host events to promote an accurate understanding of Paganism and Earth-based spirituality, foster an accepting, tolerant and loving community, aid in charity with regards to the community and environment, and organize public activities to help strengthen knowledge, understanding and tolerance within the community for all spiritual faiths.

ADD - ARTICLE VIII

No part of the net earnings of WEST CENTRAL FLORIDA PAGAN ALLIANCE, INC shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No officer or director of this corporation shall be personally liable for the debts or obligations of WEST CENTRAL FLORIDA PAGAN ALLIANCE, INC of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

Upon termination or dissolution of the WEST CENTRAL FLORIDA PAGAN ALLIANCE, INC any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.

The organization to receive the assets of the West Central Florida Pagan Alliance, Inc. hereunder shall be selected by the discretion of a majority of the managing body of the West Central Florida Pagan Alliance, Inc. and if its members cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the West Central Florida Pagan Alliance, Inc. by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

In the event that the court shall find that this section is applicable but that there is no qualifying organization known to it which has a charitable purpose, which, at least generally, includes a purpose similar to this corporation, then the court shall direct the distribution of its assets lawfully available for distribution to the Treasurer of the State of Florida to be added to the general fund.

No substantial part of the corporation's activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any activities not permitted to be carried on (I) by a corporation exempt from federal income tax as an organization described by Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (II) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ADD - ARTICLE IX

There shall be no voting members.

Non-Voting membership provisions of this corporation are defined in the bylaws.

The board of directors may approve classes of non-voting affiliates with rights, privileges, and obligations established by the board. Affiliates may be individuals, businesses, and other organizations that seek to support the mission of the corporation. The board, a designated committee of the board, or any duly elected officer in accordance with board policy, shall have authority to admit any individual or organization as an affiliate, to recognize representatives of affiliates, and to make determinations as to affiliates' rights, privileges, and obligations. At no time shall affiliate information be shared with or sold to other organizations or groups without the affiliate's consent. At the discretion of the board of directors, affiliates may be given endorsement, recognition and media coverage at fundraising activities, other events or at the corporation website. Affiliates have no voting rights, and are not members of the corporation.

ADD - ARTICLE X

Any amendment to the Articles of Incorporation may be adopted by approval of two-thirds (2/3) of the board of directors.
