■ Celebrating the 20th anniversary of the Lemur Conservation Foundation (LCF), the foundation seeks to raise \$2.2 million in the next three years. "I am delighted to announce" said LCF's Executive Director Alison Grand, "that we have secured \$1.1 million in commitments and have attained half of our goal. This is due largely to the spectacular sustained support of our trustees."

Chief campaign priorities include: increasing forest habitats and shelters for LCF's growing population of endangered animals; providing a new veterinary clinic and quarantine shelter; building a maintenance shop and underwriting expanding research and educaIn the past 15 years, the lemur reserve has tripled in size, growing from 40 acres to 130. As a conservation breeding facility, the lemur population has quadrupled to 56 animals on the reserve with additional animals transferred to other Association of Zoos and Aquariums (AZA) facilities to preserve the genetic diversity of these endangered primates. The number of on-site facilities has also tripled and the "campus" is being reconfigured to enable the lemurs to "free-range" more readily.

"While we are not generally open to the public", says Dr Grand, "we do host a few special events, including an open house and patrons' tours that can be arranged."

■ Rose Chapman has been elected chair of JoshProvides. She has worked in the nonprofit world for more than 40 years. Chapman's nonprofit career began in 1973, four years prior to obtaining her Master's in Social Work. She has been a member of the JoshProvides Board of Directors for four years and was nominated as Board Chair at this month's annual meeting.
