- 1) How long is the program? How much does it cost?
Answer: 1 night a week for 4 years. (*nights vary, but hours are 6pm-11:00pm*) Financial Aid is not available for this program because classes are free to students employed by a Member Contractor. Students pay for their books and registration fee each year. Book price will vary depending upon student year level. The registration fee is a yearly fee.
- 2) Do I need to work AND attend classes?
Answer: Yes. The program is designed for students working in the electrical trade.
- 3) How do I get a job?
Answer: You are given a list of contractors during the application process, and you call each one every other week to request an interview with the hope of obtaining a job. We do not place you with a contractor, and we do not guarantee everyone finds employment. Employment depends upon the current economy of Brevard County and how it's affecting our Member Contractors. Student must work with a Member Contractor in order to receive credit for their work hours. Member Contractors are on file with the State of Florida attached to this program. Student is allowed to attend ONE TERM without employment, but cannot be registered after that if they are not working for a Member Contractor.
- 4) Where are the classes held? When does school start?
Answer: School location may vary depending upon year level. School starts every August. Students cannot enter mid-year in January. Applications are accepted year round. Classes may be 1 night a week OR 2 nights a week for 4 years. Each year will depend upon location and instructor availability. Nights & times may vary per instructor availability also.
- 5) When should I set an appointment to fill out an application?
Answer: As soon as possible. We take applications year round. The deadline for the upcoming August is the 2nd Wednesday in July. After that, everyone goes into a pending file for the NEXT August. Call the office or email us through the website to request an application appointment. (*the sooner you apply, the more likely of being hired quickly*)
- 6) How old do I need to be, and do I need a high school diploma?
Answer: 17 years old WITH a high school diploma and parental permission, or 18 years of age and no high school diploma or GED. A 17 year old might have to wait until they are 18 to find employment, but can still attend class for ONE TERM without employment.
- 7) How much money can I make as a student?
Answer: There is a program minimum amount per hour that is usually more than national minimum wage, but the amount changes every August. Also, some contractors pay more than the required program minimum, so pay will vary per contractor and per students' previous experience and education.
- 8) What do I need to graduate?
Answer: 4 years of completed classroom education and 8000 On-the-Job Training (OJT) work hours. Students w/o enough hours at the time of graduation may obtain a partial graduation & then continue to turn in OJT hours until the required hours are fulfilled.
- 9) When can I take the test for my Journeyman's License?
Answer: After you have successfully completed 2 years of school, and have 4000 OJT hours on file with the apprenticeship office. (*many students wait until they have graduated from the program and then take the test the summer after their graduation*)
