In consideration of the above, party of the first part agrees to pay to party of the second part the
Sum of \$ n/a for each concession n/a
15 % of the gross receipts of all rides after the first \$8,000.00.
Little Egypt Shows to have exclusive rights for corn dogs, funnel cakes, shake ups & cotton candy.
Armbands available Friday, and Saturday 5-10pm Armbands \$20.00 each. Office tickets \$3.00 each (1 ticket
per ride).
It is further understood and agreed by both parties hereto that there shall be no other riding devices,
shows or attractions, other than those furnished by party of the first part.
It is also mutually agreed by the parties hereto that should any other or additional agreement become
necessary, the same shall be void unless reduced to writing and signed by the parties hereto.
It is further understood that this agreement is part or entirety is subject to strikes, suspension of
electric service, failure of transportation facilities, Government decrees or other good and sufficient reasons
beyond the control of either party hereto.

This memo is in regard to a request for review and evaluation of a reimbursement request submitted pursuant to the New Home Development Program.

Developer: John D. Tanner (Owner)

Project Location: North 5th Street, Vienna, IL

Amount Requested: \$10,000.00

Pursuant to the New Home Development Program, approved applicants are eligible to receive reimbursement from the TIF Fund in an amount up to \$10,000 for eligible redevelopment project costs incurred during the construction of new homes which meet the guidelines and specifications of the Program.

At this time, the Developer has submitted a Request for Reimbursement in accordance with the program, which includes invoices, receipts, and other evidence of costs incurred during the performance for the work.

In review of this request and all supporting materials, it would be our opinion that the Developer has incurred at least \$10,000 in program eligible redevelopment project costs.

Not having personally observed the completed work or verified that all work items have been performed, it will be the responsibility of the City to confirm that all work has been completed as expected, and to the satisfaction of the City, in the City's sole discretion.

If it is determined that the work has been performed to the City's satisfaction, it is our opinion that payment may be considered for disbursement in the maximum allowable amount of **\$10,000.00**.

**NOTE:** This memo does not represent a legal obligation for payment and is only an expression of our opinion on the obligations of the City in accordance with the agreement(s) which the City is believed to be a party to. Payment(s) should receive approval from the City Council before funds are disbursed. Upon approval, payment should be made within 60 days.
