## MEMORIAL DAY

Memorial Day was originally known as Decoration Day because it was a time set aside to honor the nation's Civil War dead by decorating their graves.

Several Northern and Southern cities claim to be the birthplace of Memorial Day, including Columbus, Mississippi; Macon, Georgia; Richmond, Virginia; Boalsburg, Pennsylvania; and Carbondale, Illinois.

In 1966, the federal government, under the direction of President Lyndon Johnson, declared Waterloo, New York, the official birthplace of Memorial Day. They chose Waterloo because the town had made Memorial Day an annual, community-wide event starting in 1866, during which businesses closed and residents decorated the graves of soldiers with flowers and flags.

In 1865, Henry C. Welles, a druggist in Waterloo, mentioned at a social gathering that honor

should be shown to the patriotic dead of the Civil War by decorating their graves. In the spring of 1866, he again mentioned this subject to General John B. Murray, Seneca County Clerk. General Murray embraced the idea and a committee was formulated to plan a day devoted to honoring the dead.

Townpeople adopted the idea wholeheartedly. Wreaths, crosses and bouquets were made for each veteran's grave. The village was decorated with flags at half mast and draped with evergreen boughs and mourning black streamers. On May 5, 1866, civic societies joined the procession to the three existing cemeteries and were led by veterans marching to martial music. At each cemetery, there were impressive and lengthy services, including speeches by General Murray and a local clergyman. The ceremonies were repeated on May 5, 1867.

Decoration Day was first more widely observed on May 30, 1868, by proclamation of General John A. Logan of the Grand Army of the Republic. On May 5, 1868, Logan issued General Order No. 11:

*General Orders No. 11  
WASHINGTON, D.C  
May 5, 1868*

*The 30th day of May, 1868, is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village, and hamlet churchyard in the land. In this observance no form of ceremony is prescribed, but posts and comrades will in their own way arrange such fitting services and testimonials of respect as circumstances may permit.*

*We are organized, comrades, as our regulations tell us, for the*

*purpose among other things, "of preserving and strengthening those kind and fraternal feelings which have bound together the soldiers, sailors, and marines who united to suppress the late rebellion." What can aid more to assure this result than cherishing tenderly the memory of our heroic dead, who made their breasts a barricade between our country and its foes? Their soldier lives were the reveille of freedom to a race in chains, and their deaths the tattoo of rebellious tyranny in arms. We should guard their graves with sacred vigilance. All that the consecrated wealth and taste of the nation can add to their adornment and security is but a fitting tribute to the memory of her slain defenders. Let no wanton foot tread rudely on such hallowed grounds. Let pleasant paths invite the coming and going of reverent visitors and fond mourners. Let no vandalism of avarice or neglect, no ravages of time testify to the present or to the coming generations that we have forgotten as a people the cost of a free and undivided republic.*

*If our eyes grow dull, other hands slack, and other hearts cold in the solemn trust, ours shall keep it well as long as the light and warmth of life remain to us.*

*Let us, then, at the time appointed gather around their sacred remains and garland the passionless mounds above them with the choicest flowers of spring-time; let us raise above them the dear old flag they saved from this honor; let us in this solemn presence renew our pledges to aid and assist those*

*whom they have left among us a sacred charge upon a nation's gratitude, the soldier's and sailor's widow and orphan.*

*It is the purpose of the Commander-in-Chief to inaugurate this observance with the hope that it will be kept up from year to year, while a survivor of the war remains to honor the memory of his departed comrades. He earnestly desires the public press to lend its friendly aid in bringing to the notice of comrades in all parts of the country in time for simultaneous compliance therewith.*

*Department commanders will use efforts to make this order effective.*

During the first celebration of Decoration Day, General James Garfield made a speech at Arlington National Cemetery, after which 5,000 participants helped to decorate the graves of the more than 20,000 Union and Confederate soldiers buried in the cemetery.

By the late 1800s, many communities across the country had begun to celebrate Memorial Day and, after World War I, observances also began to honor those who had died in all of America's wars. In 1971, Congress declared Memorial Day a national holiday to be celebrated the last Monday in May.

Several Southern states continue to set aside a special day for honoring the Confederate dead, which is usually called Confederate Memorial Day:

Today, Memorial Day is celebrated at Arlington National Cemetery with a ceremony in which a small American flag is placed on each grave. Also, it is customary for the President or Vice President to give a speech honoring the contributions of the dead and lay a wreath at the Tomb of the Unknown Soldier. About 5,000 people attend the ceremony annually.

## Certification Corner

Due to no one participating in the American Law and Administrative Agencies quiz last month, we could not announce a winner. The answer key is attached for your reference.

It is time to start studying if you want to take the ALP, PLS/CLP or PP exam in September. The registration deadline is August 15<sup>th</sup>. Below is information regarding eligibility and a description of what each exam covers. If anyone would like additional information about any of the exams, please contact me. I can provide you with a flash drive containing the study materials and mock exams that I have accumulated to date.

It may seem like a daunting task to study for any of these exams, but I can assure you that it will be worth your while to do so.

### ALP Examination Eligibility

To sit for the exam, you must have completed one of the following:

Completion of an accredited business/legal course,  
Completion of a NALS Legal Training Course, or  
One year of general office experience.

### The Exam Covers

**PART 1:** Communications

**PART 2:** The Law Firm: Legal Procedures and Knowledge

**PART 3:** Legal Ethics and Authority

### PLS and/or CLP Examination Eligibility

Any person who has had a minimum of three years of experience in the legal field may take the examination. Membership in NALS is not a requirement. A partial waiver of the three-year legal experience requirement may be granted for post-secondary degrees, successful completion of the ALP exam, or other certifications. The maximum waiver is one year. All waiver requests must be submitted, in writing, to NALS National Certification and Education Manager.

PART 1: Written Communications  
PART 2: Office Procedures and Technology  
PART 3: Ethics and Judgment Skills  
PART 4: Legal Knowledge and Skills

### PP Examination Eligibility

To be eligible to sit for the Profession Paralegal exam, candidates must meet one of the following criteria:

- Have a minimum of five years of experience performing paralegal/legal assistant duties.
- Hold a bachelor's degree in paralegal studies.
- Have graduated from an **ABA-approved Paralegal Program**.
- Have graduated from another accredited paralegal program which consists of a minimum of 60 semester hours and/or 900 clock hours, of which a minimum of 15 semester hours and/or 225 clock hours were in substantive law.
- Hold a bachelor's degree in an unrelated field and have a minimum of one year of experience performing paralegal/legal assistant duties.

### Student Waiver

Students of an accredited or ABA-approved paralegal studies program who are near graduation may sit for the PP exam provided that NALS receives a copy of their college transcript and a letter, on official university letterhead and signed by the program director, confirming the student's graduation date (*must be within a three-month window*). If the student does not successfully graduate from his/her program, the results of the PP exam will become null and void and the exam fee forfeited.

### Request For Partial Waiver

A partial waiver of the five-year requirement for paralegals is possible if an individual has a minimum of three years' experience performing paralegal duties. The maximum waiver is two years. You must request the waiver, in writing, to NALS' National Certification and Education Manager.
