Board Meeting Highlights Regular Board Meetings are the Third Thursday at 6:30 PM

October – During public comment, Kenneth Eaton informed everyone that he was a candidate for the CLAWA Board of Directors. Supervisor Miller reported on the Badger Lane pipeline project progress and the efficient completion of the annual sewer cleaning and video inspection. Using District personnel to assist the contractor, Houston & Harris, saved the District about \$3500. Chief Hall reported on the spec and bid process for the new Type I Fire Engine and the sandbags

at the Fire Station. General Manager Huff reported on the MAC meeting he attended regarding mountain incorporation and the audit. The Board adopted a resolution adopting NIMS as the Fire Departments response management system.

November – Supervisor Miller reported on plans to build a rock sifter this winter so they could clean and reuse the dirt piles by well #2. Chief Hall announced the upcoming Christmas festivities happening with the Fire Department. General Manager Huff reported

on the progress of the recruiting and hiring process for a new district Serviceperson and the beginning of talks with Running Springs regarding a new Wastewater Treatment Agreement. He also presented a graphic analysis of well levels over the past two years that show well levels up an average of twenty feet in the last year. This, along with a request from Running Springs, led to a decision to increase water sales to Running Springs from 25 gallons per minute to 35 gallons per minute. The increase in water sales will result in about \$1000 in additional revenue to the District each month. This additional revenue allows the District to continue to provide water services for the lowest rates on the mountain and fund ongoing infrastructure projects. The Board discussed and amended the residency requirement for critical District employees. The Board determined that it was important for the critical employees to be readily available for accidents or emergencies. The amended residency requirement of within 10 miles would provide that level of service. The Board also discussed and awarded the new Type I Fire Engine contract to KME.

December – Secretary Rimmer swore in newly appointed incumbent Board Members Sheila Wymer, Mark Bunyea, and Terisa Bonito for new four year terms. Supervisor Miller reported on the completion of the Badger project, main repairs, and frozen pipes. General Manager Huff reported on the status of the Wastewater Treatment agreement discussions with Running Springs. The Board approved a resolution increasing the District healthcare contribution limits and a motion to approve the new fire engine lease with Leasing 2, Inc.
