Our mission is to promote public awareness and interest in Sober Living Homes and to campaign for legislation to insure that these facilities are HELD RESPONSIBLE for the safety and well being of recovering addicts.

SOBER LIVING HOMES ACCEPT RECOVERING ADDICTS WHO ARE THERE usually because of family support – but MANY TIMES BECAUSE OF COURT MANDATE. They exist all over the country in residential and rural neighborhoods and MANY TIMES WITHOUT STATE OR LOCAL PERMITS.

Unfortunately, deaths due to overdosing and neglect happen every day in Sober Living Homes. Jarrod's Law believes that these facilities should not be able to house vulnerable recovering addicts and call themselves a "drugfree environment" if there are no FAIL-SAFES in place. ACCOUNTABILITY must start with state or federal regulations to have the power to close down facilities that do not provide a safe environment.

Sober Living Homes apply to the IRS for non-profit status and DO NOT PAY TAXES. They do this by claiming to provide services, such as counseling, or say they are "treatment centers" when in reality some do nothing but collect costly rents, house recovering addicts in UNSAFE and INADEQUATE quarters, and expose the residents to hazards that interfere with their recovery and wellness.
