### REPORTS OF SUPERVISOR AND COUNCIL

Supervisor Tompkins wanted to wish everyone a Happy New Year and thank all of those that helped her throughout the last year, especially the Town Hall staff and Parks and Recreation Department. She wanted to clarify how the Planning Board and Zoning Boards are paid, she explained that each member that attends receives \$100 a meeting there is no longer a flat rate for the year. If someone is unable to attend and an alternate steps in, the alternate would be paid the \$100 for the meeting. She also noted the health insurance buyout has been eliminated for 2017. She also wanted to discuss the land on Route 55 that the Town owns. She would like it to be assessed and listed as soon as possible. Mary Pearson, Program Director, made a request for an Apple computer.

### REQUEST TO PURCHASE COMPUTER

The Parks & Recreation Department would like to purchase a MacBook Pro 13-inch laptop, costing \$1688.91 from the Apple Store. The funds have been allocated for this purchase in the 2017 budget. They have provided two quotes, one from the Apple Store for Government (which provides discounted rates for municipalities) and one from BestBuy (\$1,898.99).

Bookkeeper Courtien checked the budget and said there may need to be a transfer as there were funds for 2 computers of lesser values.

### MOTION TO PURCHASE MACBOOK

Councilman Welsh made a motion to authorize the Parks and Recreation department to purchase the MacBook Pro 13-in laptop for \$1,562.00 Councilwoman Kelley seconded the motion and all were in favor.

Councilman Welsh had been on the phone with a retired Park manager, he is about to go on Medicare and would like to switch to United Health Care as a recommendation from Bill Humphry's. This was resolved ahead of time which Councilman Welsh was informed Councilman Frazier had phone Mr. Welsh who is ill was asked that he be approved to attend the Attendance for Association of Towns. Supervisor Tompkins said it is approved for Councilman Frazier and Councilman McMorris and Councilman McMorris will be the delegating member.

### MOTION AUTHORIZING ASSOCIATION OF TOWNS ATTENDEES

Councilman Welsh made a motion to allow Councilman Frazier and Councilman McMorris to attend the 2017 Association of Towns Training in New York City this February. Supervisor Tompkins seconded the motion and all were in favor.

Supervisor Tompkins said she would like all motions to become resolutions so that they may be numbered to keep track on all items and make it more organized for the Clerk's office.

Councilman McMorris said he has been speaking to BlueRock Energy who is offering a 3-month rate of 7.5/cents per KW HR which does not include the Equestrian Center which has been shut off for the winter, the pool house or Godfrey Park which is not used during the Winter. This will allow them the time to figure out where they can purchase energy in the future.

### MOTION TO CONTRACT WITH BLUEROCK

Councilman McMorris made a motion to allow BlueRock Energy to provide electricity needs for the next 3 months beginning in February. Councilman Welsh seconded it and thanked both for all their hard work and efforts. All were in favor.

Supervisor Tompkins noted that Councilman McMorris had been keeping a close watch on the energy consumption and had the electricity turned off the in Equestrian Center until April to save \$45 dollars a month. Councilman McMorris stated that LEM Developers may be interested in purchasing the Route 55 property. There are new incentives from the Government by switching to solar power. Supervisor Tompkins stated that the resolution for the appraisal will be done by the attorney ready for next meeting.
