To Do or Not to Do

What does a New York postal clerk wearing a political button at work, a letter carrier from Wisconsin soliciting political contributions on his route, and a USPS maintenance worker from Florida running for a partisan office have in common? They are all in violation of the Hatch Act.

Carl Hatch from New Mexico, sponsored the Hatch Act in 1939. This seemingly obscure, but serious law protects federal employees from political coercion in the workplace, keeps elections fair, and enforces political neutrality among civil servants It also places many prohibitions on federal employees including postal workers. Amended in 1993, this law is specific found guilty may be subject to discipline and or as to what a federal employee may or may not do in regard to political activities. The list of restrictions includes rules such as federal employees may not participate in partisan activity while on duty, at the workplace or in uniform or wear, display, or distribute partisan materials. This is where the Auxiliary comes in. Auxiliary members who are not employed by the USPS, are not bound by the Hatch Act and are free to take political actions that benefit our union brothers and sisters. This alone makes an Auxiliary necessary to the APWU. We can advocate in favor of the issues backed by the APWU and in turn help preserve postal jobs and benefits. It is imperative that all of us, postal employees or not, understand the restrictions and limits that are spelled out in the Hatch Act.

Social media has added many more avenues for communication. We can now tweet, retweet, post, chat, share, like, or comment with a keystroke. We need to be mindful that all rules still apply. If a postal employee is at work, they may not violate the law, for example, like a friend's post encouraging others to vote for a favored candidate in a partisan race, even if they are on break using their own private cell phone, tablet, or laptop Employing an alias or screen name other than your own to circumvent the Hatch Act is not allowed. If something is not legal under your name it is not legal under any moniker you use. Employees may display a political party, logo, or a photo of a particular candidate on their personal Facebook or Twitter accounts as long as they do *not* post on those accounts while at work.

Employees are never to knowingly solicit, accept, or receive contributions for a candidate or party in a partisan race. This means they may not like, repost, retweet, or share a message from someone else asking for donations. Social media profiles with job titles and party affiliations are allowed even if the account is used, *off postal property*, for political activity, but comments supporting partisan candidates cannot include the postal worker's job titles. This falls under using official titles to influence political races.

The Office of Special Council, OSC, is authorized to investigate violations of the Hatch Act. Employees termination. Ignorance of the law is not an acceptable defense. Don't let confusion of the law get you in trouble. If in doubt, I urge you to contact the OSC. You may call (800) 854-2824 or go on-line to hatchact@osc.gov.

The *e-postcard* is due every year by the 15th day of the 5th month after the close of your tax year. For example, if your tax year ended on December 31, the *e-postcard* is due May 15 of the following year. If the due date falls on a Saturday, Sunday, or legal holiday, the due date is the next business day. You cannot file the e-postcard until after your tax year ends.

Auxiliary to the APWU Nilan Scholarship for Lifelong Learning

RULES & GUIDELINES - FOR 2019 SCHOLARSHIP

- 1. NO 2018–2019 high school graduates will be considered for the 2019 scholarship. Applicant MUST have had a break from High School of one year or more.
- 2. Applicant must be a member in good standing with APWU National Auxiliary. The applicant must have been an Auxiliary member in good standing, for at least one (1) year prior to application deadline.
- 3. Application must be on official application form from the APWU National Auxiliary Continuing Education Scholarship Program.
- 4. Applicant must write an essay on the designated subject of no less than 175 and no greater than 250 words.
- 5. Completed application form with essay must be mailed to: Chairperson Rebecca Kingsley (the address on back) postmarked no later than July 1, 2019, by certified mail with return receipt requested.
- 6. Applicant must be registered, enrolled or attending an accredited college (college, university, vocational or technical school, etc.) at the time the scholarship is given.
- 7. The APWU National Auxiliary will award one (1) yearly scholarship of \$500.00
- 8. Upon verification that the recipient has enrolled with the school of his/her choice, the award will be sent to the business office of the school to be applied to the cost of books, food vouchers, and or tuition. Scholarship must be used within 18 months of award date.
- 9. The scholarship recipient is eligible to receive one (1) yearly scholarship for a maximum of two (2) years upon reapplication & selection process in accordance with the rules and guidelines of the scholarship.
- 10. In the event that the recipient drops out before the completion of the course(s) (and within the refundable time frame) any unused funds that have already been sent to the recipient school for continuing education shall be refunded back to the National Auxiliary to the APWU.
- 11. No member of the APWU Auxiliary National Executive Board or their family will be eligible for this scholarship.
- 12. No exceptions will be made to these rules.

National Health Plan

High blood pressure threatens your health and quality of life

In most cases, the damage done by high blood pressure (HBP, or hypertension) takes place over time. Left undetected (or uncontrolled), high blood pressure can lead to:


- Heart attack: High blood pressure damages arteries that can become blocked and prevent blood flow to the heart muscle.
- **Stroke:** High blood pressure can cause blood vessels in the brain to clog more easily or even burst.
- Heart failure: The increased workload from high blood pressure can cause the heart to enlarge and fail to supply blood to the body.
- Kidney disease or failure: High blood pressure can damage the arteries around the kidneys and interfere with their ability to filter blood effectively.
- Vision loss: High blood pressure can strain or damage blood vessels in the eyes.
- Sexual dysfunction: High blood pressure can lead to erectile dysfunction in men or lower libido in women.
- Angina: Over time, high blood pressure can lead to heart disease or microvascular disease (MVD).
 Angina, or chest pain, is a common symptom.
- **Peripheral artery disease (PAD):** Atherosclerosis caused by high blood pressure can cause a narrowing of arteries in the legs, arms, stomach and head, causing pain or fatigue.

Your best protection is knowledge, management and prevention

- Know your numbers: The best way to know if you have high blood pressure is to have your blood pressure checked.
- Understand the symptoms and risks: Learn what factors could make you more likely to develop high blood pressure and put you at risk for serious medical problems.
- Make changes that matter: Take steps to reduce your risk and manage your blood pressure.
 Make heart-healthy lifestyle changes, take any medication as prescribed and work in partnership with your doctor.

High blood pressure and hypertensive crisis

• If your blood pressure readings suddenly exceed 180/120 mm Hg, wait five minutes and then test your blood pressure again. If your readings are still unusually high, contact your doctor immediately.
