**Hello!...and Welcome** to Rice Creek Hunting Dog Club's Annual Flushing Breed Hunt Test. We are so glad that you chose to join us for what is always a great weekend of dogs, good friends, and fun! For those of you that have been with us before, welcome back. We look forward to catching up on all that you've been up to since we've seen you last. And for those of you that are new to the festivities here with Rice Creek, come on in. Sit down, take a load off. We're happy to meet you! Give us a couple minutes, and we'll give you a little run down on what's going on, and some information that we hope you will find helpful. Entry forms can be found at [www.rchdclub.com](http://www.rchdclub.com) under the events tab. **REFUNDS** – As stated in “Regulations for AKC Hunting Tests for Spaniels” Chapter 1, Section 5: Entry fees will be refunded in full for bitches in season, or if your dog is injured, ill or has died. Prior to paying such refund, RCHDC requires an appropriate veterinary certificate. In the event the dog is withdrawn for other reasons after the closing date, the Club will retain a \$25.00 handling fee to cover related expenses. If withdrawn before the closing date; refunds will be paid in full.

## How to find us...

This year, we will be returning to our roots and holding the test on the grounds at Rice Creek Hunting and Recreation just east of Little Falls, MN. Joe, Greg and the whole crew have been gracious enough to welcome us back, and we do so much appreciate it. With over 1300 acres of mixed cover, and plenty of water, it gives dogs, handlers, and judges a great opportunity to show what they're made of. Directions to the grounds are as follows: Take US-10 to the exit for Minnesota Highway 27 at Little Falls. Turn east on Highway 27. Just past the Falls Ballroom, make a left onto Hawthorne Road. Follow Hawthorne Road north and then east, for approximately 5 miles. It will be on the right side of the road. Look for signs pointing to the Rice Creek Hunting Dog Club event.

**We ask that you do not go to the clubhouse as they have a private event booked there for the weekend.**

## What to bring...

For the folks that are new to hunt tests, there are a few items that can make your day with us a whole lot more comfortable and enjoyable for you and your canine buddies. For those of you that are old hands at this hunt test game, you know what you and yours need for a day in the field, but why not take a minute to glance through the list, just to make sure you don't forget something.

- 1) **Water**-for people and dogs, the most important thing you can do to make sure everybody is happy and healthy is to make sure you have plenty of water, and a way to carry it with you in the field. Canteen, ketchup bottles, plain old water bottle, or the latest and greatest in Camelback gear, make sure you have a way to keep hydrated. Tubs and water to soak your dog down before and after their run will be provided by the club, and available at the line. Pop and water will be available, but it never hurts to bring along your particular favorite.
- 2) **A way to “Chill out”**-While we have tents set up for our “after the test festivities”, there isn't a whole lot of extra room for setting crates and such inside. If you have an EZ Up tent, an awning, or even just a blanket or tarp, it can make your time waiting that much more comfortable. And of course, what better way to enjoy your drinks and shade, than while lounging in your lawn chair. **NOTE:** Consuming alcoholic beverages will not be allowed until after the event has closed for the day.
- 3) **Munchies**-While RCHDC is world renowned for our “After the Hunt Feed”, we don't have anything to speak of by way of a lunch. There are convenience stores and fast food restaurants in nearby Little Falls. But to keep the hunger pangs at bay, at a more reasonable price, until we get the real food on in the afternoon, you might want to pack along something to nibble on along the way.
- 4) **Speaking of Munchies**-While we are on the subject of food, you may or may not know that after the hunt, we throw a feed that is second to none. We have a gourmet chef on our membership roster, as well as multiple members that can boast many, many hours of kitchen time. We take the game harvested throughout the day, clean and prepare it on site, and serve it up along with whatever “pot luck” happens to show up. But whether you have something to bring or not, **YOU ARE WELCOME TO STAY AND EAT!!!!** We are just happy that you chose to spend your day with us!!!
- 5) **Blaze Orange**-While everything to this point has been a friendly suggestion, this point is NOT negotiable. AKC regulations, as well as common sense, dictate that all participants and spectators have and wear at least one article of blaze orange clothing when in the field. Preferably a shirt or vest, but a hat is acceptable. The more the better, for the most part. We are happy to have you here. And we want everybody going home happy, tired, and walking at the end of the day.
