Caretaker Policy

Springfield Swim Club (SSC) has created a limited number of special passes for pool admission called "Caretaker Passes". The purpose of these passes is to provide members of SSC the opportunity to purchase single season admission for individual's charged with the care & supervision of family members under the age of thirteen.

Members who purchase caretaker passes do not in any way assign added liability or responsibility to the Springfield Swim Club or its management. The caretaker must be pre-approved by the SSC Board of Directors via application made by the member. The pool & its management reserve the right to retract a caretaker pass at any time for violation of pool rules.

Caretaker Policy Guidelines

1. Requesting member family must apply for a caretaker pass, and upon notification of approval, pay a fee of \$100 for caretakers who are not members of the pool for a caretaker pass. There is a limit of one caretaker pass per family.
2. A special pass for the caretaker will be created. The pass will be issued to the family member.
3. Members and approved caretakers must attend a special meeting prior to season opening to review pool rules & caretaker policy guidelines. If the Caretaker is not a SSC member, use of Springfield Swim Club is limited to the privileges of the caretaker pass. The date of the meeting will be announced in the annual spring mailing.
4. The caretaker must be at least 16 years of age. Upon each arrival at the pool, caretakers must identify the children in their care to the gate personnel. Gate personnel will keep a daily log indicating the caretakers & the children in their care.
5. No caretaker may be charged with caring for more than one member's children at any given time. Each member must specify the children for whom the caretaker is approved to supervise in the caretaker in the caretaker application.
6. Caretaker passes may only be used Monday through Friday from pool opening until 6PM and when no family member who is sixteen or older is on pool grounds.
7. The caretaker must be in close proximity of the children within their care & always aware of their whereabouts. The caretaker may not leave the pool grounds unless all children signed in under their care for that visit are with them.
8. Caretakers may not sign in guests while acting as a caretaker, regardless if they themselves are pool members.
9. Applications for passes may only be made after March 15 prior to the start of the season and must complete a written application. Caretaker passes will be awarded on a first come first serve basis.
10. Payment in full must be received for both regular membership & caretaker pass prior to receiving a caretaker pass. If payment is not received by opening day of the season, the pass may be awarded to the first member on a waiting list if one exists.
11. Caretaker passes may not be transferred without approval from the SSC Board of Directors.
