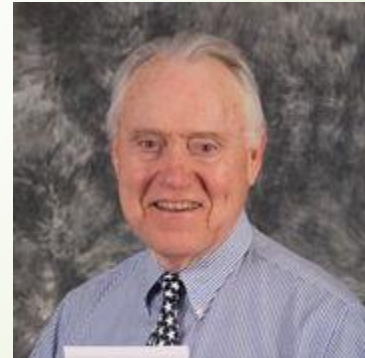

## To receive the Course Final Passwords:

- Click on the following link to set up an [eHawaii Account](#). The Course Completion Certificate will be issued in the exact name you registered with eHawaii Account;
- I suggest you use your name as it appears on the ID you will be taking to the PSI Test Center; otherwise there could be confusion at the PSI Test Center. You can submit a name change to Hawaii Real Estate Branch later.



## Scan and Email

# Arrange for a Test Proctor

- Someone not related to you that will be present when you are testing that will sign an affidavit that it was you that took the test and that you did not use your textbook or notes, etc. You may use a friend, business associate, neighbor, real estate broker, title or escrow officer, etc.
- Go to the Hot Links section of my website and print out two copies of the Certification of Course Final to be completed by the test proctor that you select. Use one for each section of Course Final. When you pass the Course Finals email the scanned sheet(s) to [info@seilerschool.com](mailto:info@seilerschool.com)



# Before you attempt the Course Finals:

- Review all the Module Tests and the results that you printed out after each Module Test
- Complete the 3 Review Quizzes at the back of your textbook.
- Be sure you are familiar with the Hawaii Association of Realtors Standard Forms, i.e. Listing Agreement, Purchase Contract, Counter Offer, etc.



# The Course Final includes

- Two sections that are graded independently.
- Uniform Portion with 100 questions about real estate in general throughout the United States.
- State Portion with 100 specific questions relating to Hawai'i rules and regulations.
- You are allowed 4 hours for each section. You can complete both sections on the same day or take them on separate days, in either sequence.
- If you do not pass you will be required to repeat that portion of the test for an additional \$25.





# The Course Final test includes a variety of question formats:

- TRUE and FALSE;
- FILL IN THE BLANK; \_\_\_\_ or \_\_\_\_ \_\_\_\_ etc.
- MULTIPLE CHOICE - only one answer may be selected;
- MULTIPLE SELECTION - these may often have MULTIPLE CORRECT ANSWERS. Place a check in each answer box you think is correct;
- MATCHING - pair an item in right column with a corresponding item in left column. The only type of question where the Student receives credit for each correct match.



# After you Complete Each Test

- You will receive your score on that portion.
- To protect the integrity of the Course Final, you will not be able to print out the answers.
- After you pass both portions, I will provide links to **Free Practice Tests** to help prepare you for the State Exam. **Be sure to take advantage of them!!**
