**SITE INFO:** This trial will be held in two rings indoors on packed dirt. There will be crating on the area outside the arena, around the bleachers. Crating space is somewhat limited, so we ask that you please conserve on space so that everyone who needs crating will be able to find a spot. Please bring chairs, crates, water and clean up tools for your dogs. If you come and help us set up, you may set up your crating space on Wednesday beginning at 3pm. Otherwise you will be able to set up Friday morning at 7am. If you set up prior to that time, we reserve the right to move your space in order to set up the secretary tables and raffle area.

### DIRECTIONS TO THE TRIAL SITE:

#### From North of Eugene

Travel south bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7<sup>th</sup> Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11<sup>th</sup> Ave. at the light. Turn left on Tyler Street and travel to 13<sup>th</sup> Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

#### From South of Eugene

Travel north bound on I-5 until you reach I-105. Take the westbound off ramp (194B) into Eugene. As the freeway approaches its end on 7<sup>th</sup> Street, stay in the middle lane. This becomes Jefferson Ave. Turn right onto West 11<sup>th</sup> Ave. at the light. Turn left on Tyler Street and travel to 13<sup>th</sup> Ave. Turn left into the far right lane and take the next right into the NW entrance to the Fairgrounds.

# SET UP: We will be setting up the rings on <u>Wednesday, Nov</u> <u>23<sup>rd</sup></u> at 3:00 PM. We'd sure appreciate your help if you're available to come down.

**MEASURING:** All dogs without height cards will have to be measured this weekend. We will have a VMO available at this trial. We will have a VMO available to measure dogs throughout the day on all days. Measuring will take place near the secretary table.

**GENERAL:** ALL dogs are required to be kept on leash at ALL times. And please pick up after your dogs.

**MOVE-UPS**: The deadline for move-ups is Monday, Nov 20, 2017 at 6 pm and must be submitted in writing (email ok). Day-to-Day move-ups will be permitted at these trials and must be submitted to the score table no later than 30 minutes after the end of the trial.

**VOLUNTEERS:** You, the volunteers, help make our trials a success. In an effort to keep entry fees low for you and yet help the clubs bottom line, we will be offering a **DAILY worker raffle**, The workers raffle will be drawn each day in the early afternoon. Prizes must be claimed by the conclusion of the trial on Sunday.

FAST CLASS WALK THRU All FAST Classes will walk together. ONE walk thru for all FAST Classes. Then we will Run Exc/Master FAST, Open FAST, Novice FAST.

The dog does not have to be entered in the show to run in the match.
