

9/9/2019

Deputy Weekley and Sgt. Galloway were dispatched to Eddy's Bridge Road for a suspicious male. Contact was made with the male who advised he was having car issues.

The Monroe County Sheriff's Office received a call in reference to a male advising that he was letting a female stay at his house on Fish Pot Road. The caller advised that he no longer wants the female at his residence due to her drug use. He also advised that she had a warrant out of Monroe County. Deputy Weekley responded to the address and confirmed that the female did have a warrant. Deputy Weekley also recovered drug abuse instruments. The female was transported to the Monroe County Jail.

Sgt. Galloway was dispatched to Moore Ridge Road for a suspicious male walking. It was the same male from earlier in the night walking back to his vehicle.

Sgt. Peska and K-9 Goofy responded to Washington Township in reference to a B&E of a home. The residence was checked inside and out. No evidence was found of anyone entering the residence.

Sgt. Peska and K-9 Goofy assisted the Monroe County Detectives on a traffic stop. An open air sniff of the vehicle was performed and K-9 Goofy gave a positive indication on the vehicle. A search of the vehicle produced narcotics and drug paraphernalia.

Sgt. Peska responded to an accident in Clarington. Unit 1 driver lost control hitting a ditch. The vehicle had minor damage and was issued a citation.

Sgt. Peska responded to a tree down on State Route 145 near the Noble County Line. Upon arriving, the tree was in the roadway and a vehicle had struck it. The scene was handed over to Noble County.

Sgt. Peska responded to a overdose on State Route 78. The male had been drinking alcohol all day and had taken several prescription pills. Upon arrival, the male was found breathing, but not responsive on the front porch. Squad 4 arrived and transported the male to the hospital. An investigation is pending.

9/10/2019

Sgt. Peska responded to a two vehicle crash with injuries on State Route 145 at the intersection of Keylor Hill Road. Upon arriving on scene, Unit 1 had gone left of center striking Unit 2. The occupants of both vehicles were checked by the squad and refused treatment for minor injuries. A Citation was issued to the driver of Unit 1 and a crash report will be completed.

Sgt. Peska responded to Kings Highway to assist Squad 4 with a male that had several deep lacerations on his chest and face. The male was cutting a piece of metal and the saw came back and cut him. He was transported to the Monroe County Airport and flown by Air-Evac to Ruby Memorial.

Sgt. Peska responded a theft of chainsaws on State Route 7 South of Sardis. While on scene Thomas Archball had a warrant out of Belmont County. He was arrested and transported to the Monroe County Jail, where he is waiting for Belmont County to pick him up. The theft is still under investigation.
