Financial Overview

The financial position of the Authority through October remained in the positive by \$4,283. This is lower than the previous month as a result of liability insurance renewals and unexpected maintenance expense. The full year projection including soft costs of depreciation and unbudgeted pension expense went into the negative of \$(9,738) for the first time in 2018. The full year projection of actual costs is projected to be positive \$164,912. This is an improvement of \$310,078 from the previous year.

A budget amendment was presented to the Board of Commissioners for Approval. \$25,552 was moved from Operational Salaries and Fringe Benefits and moved to Repairs and Maintenance. This amendment did not change the bottom line of the 2018 Approved Budget.

New Business

- Library Contract: The contract with the Ocean County Library for free parking on the top and middle levels of the Municipal Garage is up for renewal in February 2019. It was recommended to amend the contract to the upper level only. This will be discussed further at the next Board of Commissioners meeting.
- The Toms River Board of Education Contract Lot J: The contract for the Sheriff Street lot is also up for renewal. No changes to this agreement are expected.

- 2018/2019 Snow Season: A meeting was held with the Toms River MUA to discuss their assistance with snow plowing utilizing the inter-local agreement currently in place. The MUA will plow all of the Parking Authority's lots with the exception of the Town Hall complex. This will be maintained by the Parking Authority's maintenance staff. The MUA will provide drivers and operators for the Authority's Bobcat and dump truck. Communication will be constant between the MUA and Parking Authority personnel during any storm events.
- **Snow Plows:** While preparing for the upcoming winter weather it was discovered that the plow used on the dump truck was in need of several repairs. These repairs will be completed by the MUA and billed to the Authority. The plow used on the pickup was extremely corroded and cannot be used. With the plowing assistance of the MUA this plow does not need to be replaced.
- **2019 Budget:** The 2019 Budget was presented to the Board of Commissioners for approval. It was decided to postpone this approval until the next meeting.
- **The White Dump Truck:** The dump truck was assessed and in need of several repairs. These repairs were made by the MUA and billed to the Authority. An ongoing concern is the condition of the chaise which is extremely rusted. The brackets that hold the tailgate on to the truck have rusted away and therefore the tailgate cannot be mounted on to the truck.
