## The ending of lockdown restrictions: what it will mean for council staff

**Derbyshire UNISON area organiser Dave Gorton met with council** representatives at an extraordinary safety committee meeting yesterday (Wednesday 14 July) to discuss revised risk assessments in the light of the relaxation of lockdown coming into effect in England from next week.

With all that in mind, Derbyshire UNISON is pleased to see **Derbyshire Dales District Council** - at all levels - is not proceeding recklessly and has written to all

members stating "We must therefore proceed with caution because this pandemic is far from over".

Dave said:

"This caution is to be welcomed. Of course we all want things to be like they were 18 months ago - but that is not going to happen next week.

"The relaxing of certain necessary safety measures at work and in society generally needs to be done with a full and proper assessment at every stage before we move on to the next.

"Otherwise, we could be plunged back into the horrors still happening over large parts of the globe.

"A working vaccination programme has been, of course, good news but simply being vaccinated doesn't eradicate the problem completely."

The individual risk assessments for your work areas and disciplines will be shared with you when they've been finalised in case you spot any omissions but UNISON is happy they are along the right track.

We have suggested several amendments on more generic matters to remove any confusion through unclear or conflicting wording which have been welcomed by the chief executive.

Dave added:

"The decision not to reopen the town hall to all public callers immediately but delay this to August will give a further opportunity to ensure both that the council has it correct now but also is able to learn from any early lessons following the lifting of most restrictions on 19 July. "Workers have a role to play in that monitoring. If you have suggestions, please make them to your line manager. Keep UNISON informed at the same time."

## **Testing and vaccinations**

For a minority of staff, new arrangements may include the necessity for them to have lateral flow tests completed because of the nature of their roles. Indeed, this may already be the case for some members. If you realise you will be one of those staff affected in this way on your return to more normal working and have any issues with testing, it is best you raise them at an early opportunity.

Any worker who, for whatever reason, has not been vaccinated but who may be expected to visit a care home or other social care setting in the course of their official work duties, may similarly want to rise this with their line manager in advance of the date later this year when it will become compulsory for some people working in the environs of a care home to have proof of a 'double jab'.

UNISON does not expect there to be problems with any council, Derbyshire Dales District Council included, shifting from the line adopted nationally under the auspices of the National Joint Council (the joint employer and unions negotiating body) regarding compulsory vaccinations. However, we think it would be better for members to pre-empt any problems by discussing with their line manager (or UNISON first) before the eleventh hour.
