The Change in description of supply of machines, installation & on hand holding machines operating hand holding training for 90 days in handicrafts unit in Jharkhand for 1 CFC of Lac craft manufacturing will be as follows:-

1. The Bidder should submit single price bid for all Lac CFC items mentioned in bid document & the Single Completed price of 100% Items of all Lac CFC will be considered as L1 Price.
2. The Payment % will be applicable for the quoted basic price of the Machines & Services. The Bidder will get 100% tax amount in all stages of the payment.
3. The Turnover of the bidder should be twice of the bid amount mentioned in the technical bid.
4. The Consumable used during the Machine Operator training will be provided by the CFC beneficiary at the time training of to the trainer.
