The War With Iraq

At the time of this writing the war with Iraq has been in progress a short two weeks. The initial euphoria of kicking Hussein's posterior and coming home has worn off and now the government is hinting at a long, protracted ground war.

Over the past several months much has been learned about the secret background of this made-to-order "nice little war" with Iraq. If we will now review the major incidents that set the war in motion we should quickly see the wisdom of President Washington's charge in his farewell address that we should stay out of the affairs of other nations problems. We should also learn that we Americans are the most ignorant people on earth when it comes to intrigue. Once again the letters U.S. must stand for Uncle Sucker.

From the very outset of this Mideast crisis, the realignment of forces as outlined in the [November-December 1990](#) issue was apparent. The Zionest West is primarily comprised of Britain, Israel and the United States, along with other countries to a greater or lesser degree. The so-called Axis powers is comprised of Russia, Germany, Japan and the Vatican with the support of the Moslem countries. We recognize that this seems difficult to comprehend. However, there are many very qualified observers who make this analysis.

In the world of intrigue of international politics, we must accept the idea of crosses and double-crosses, agents and double-agents. Such is the case in the instance of the war with Iraq.

The signal for war became evident in the spring of 1990 when Yitshak Shamir, the prime minister of Israel, was able to organize his cabinet whose prime concern was the expansion of "Greater Israel." There was only one way to expand and that was to take over more and more of the West Bank and eventually all of Jordan. King Hussein of Jordan tried valiantly and very eloquently to forwarn the world of this but to no avail.

Then, the need for a war became more obvious in the early summer of 1990 when Russia and Israel agreed to the emigration of millions of Russian Jews to Israel. In reality, these emigrants from Russia are "Jews" in name only. Their closest connection in most cases being a grandparent. This means that they want a very large number of warm bodies with which to justify to the world that they need to expand into Jordan. In other words, it is a ploy to enable Zionism to realize their "Greater Israel." The United States backed this agreement totally because of the Zionest control of Congress and the White House. Of course, this was a signal to the Palestinians that the final act of Genocide against them as a people was about to commence.

Once again, the United States and Britain, misread Russia. It was not that Russia was in favor of "Greater Israel." They wanted to get rid of the Russian Jews!

However, because of this "most generous act" on the part of the Russians and also because of the "democratization" of Eastern Europe, the United States determined that the Soviets were no longer a military threat. We are told that we are now entering into a period of peace and brotherhood with the U.S.S.R.

Perhaps some measure of influence on the Zionist controlled West (once the Christian West) was the knowledge that Israel has been contemplating a pre-emptive strike on Iraq for nearly five years. Israel reasoned that the one nation in the Mideast that possessed a true threat to Israel was Iraq and, of course, Iraq was being backed by Russia. More will be said on that seeming discontinuity later in this brief.

Israel estimated that it would require a war chest of approximately 25 billion dollars for the strike. A large share of those funds was being obtained from the sales of arms to third world countries. The Iran-Contra affair is but one example. Another source was revealed by the ex-Mossad officer Victor Ostrovsky in his book *By Way of Deception*. He showed that another Mossad officer Mike Harari was in Panama as a special advisor to Noriega of Panama. He was shipping drugs out of Panama on Israeli Air Force planes!

To further complicate the matter, Israel concluded a secret agreement with Germany in January 1990, under extreme pressure from the United States, for Germany's Howaldtswerke Shipyards Company Ltd. in Kiel to build two special submarines for Israel. The cost would be one billion dollars. The purpose of the submarines would be to attack Iraq from the sea with chemical and nuclear weapons. These submarines were to be completed by early 1992.

Iraq learned of the planned pre-emptive strike by Israel and consequently started plans for a pre-emptive strike of their own. The Zionist West didn't want Israel and Iraq to go to war alone because that would be but another repeat of the 1968 and 1972 wars which were local in nature. The Zionist West had bigger plans. If the Zionist West was careful in planning the strategy, a full scale war with Iraq could be used to bring into being the final stages of their concept of a "One-World Government." This would be the fulfillment of the conspiracy set in motion by Oliver Cromwell and Manesseh Ben Israel.

In all probability the Israelis conceived the idea of the pre-emptive strike in order to incite the super-powers into action. Whatever is the case, we now know that the Zionest West and Russia started planning for this war soon after Yitzhak Shamir organized his "Greater Israel" cabinet.

President Bush was so sure of his position at the time of the invasion of Kuwait by Saddam Hussein that he openly and arrogantly to the point of ad-nauseam stated that he was bringing in the "new world order" by rescuing Kuwait from the clutches of this "mad-man Hitler dictator." The shock of his life was yet to come.

The United States and Russia quietly prepared Iraq for the invasion of Kuwait. Kuwait was undoubtedly chosen as the target because of the natural affinity of Iraq for Kuwait. Iraq has desired the return of Kuwait to Iraq for a long time and they knew that Saddam Hussein would grab the chance to make the conquest. Here again was the Hegelian Dialectics in action.

Russia, with help from the United States, armed Iraq to the extent that she became the fourth largest military power in the world. It has been reported that Russia has placed in Iraq exotic weapons that have yet to be revealed. These weapons are known as post-nuclear scalar wavefront technology. Why haven't they been used so far? These weapons are probably not under the control of Saddam Hussein and more about that in a moment.

When everything on the stage for this play was ready, the United States openly inticed Hussein into attacking Kuwait. Yes, that is true and most of the nation's first line newspapers and periodicals revealed that fact. The September 23, 1990 New York Times carried a detailed transcript of U.S. Ambassador to Iraq, April Glaspie's official meeting with Iraqi President Saddam Hussein. The meeting was in Bagdad, on April 25, only days before the invasion. In that meeting Ambassador Glaspie said this, "We have no opinion on the Arab-Arab conflicts, like your border disagreements with Kuwait. I was in the American Embassy in Kuwait during the late 60's. The instruction we had during this period was that we should express no opinion on this issue and that the issue is not associated with America. James Baker has directed our official spokesmen to emphasize this instruction. We hope you solve this problem using any suitable method..."

Ambassador Glaspie's boss at the State Department was John H. Kelly, Assistant Secretary of State for Near Eastern & South Asian Affairs. Two days before the invasion he repeated the same message as Glaspie gave Saddam in open Congressional testimony.

On September 18th, at a hearing before the House Foreign Affairs subcommittee, Representative Lee Hamilton (D., Ind.) told Kelly: "You left the impression that it was the policy of the United States not to come to the defense of Kuwait....I asked you (at the earlier hearing, before the invasion) if there was a U.S. commitment to come to Kuwait's defense if it was attacked. Your response over and over was that we have no defense-treaty relationship with any Gulf country."

On Sept. 17, 1990 the Washington Post described another public signal that the Administration made before Iraq's invasion. The Washington Post printed this: "In the same week that Glaspie met with Saddam Hussein, Secretary of State Baker's top public affairs aid, Margaret Tutwiler...said that the U.S. was not obligated to come to Kuwait's aid if the emirate were attacked."

No, there is no question that our country intentionally sent the signal to Saddam Hussein to go ahead and attack Kuwait.

In the meantime, the other half of the Hegellian Dialectics was hard at work. To show that there was collusion with Russia in the invasion of Kuwait, on August 8, 1990, the Wall Street Journal stated: "Soviet and U.S. policy makers have been in daily contact by phone and telex on the Iraqi crisis, Soviet officials say."

On August 22, 1990 the New York Times reported: "As longtime allies, Moscow and Baghdad cooperate closely in military and intelligence-gathering operations. Including technical support personnel, the Soviet Union has between 3,000 and 4,000 military advisers in Iraq." The New York Times also stated: "Sources in the U.S. Defense Intelligence Agency contend that it would have been virtually impossible for Mr. Hussein to have launched his invasion of Kuwait without the technical and operation of Soviet military advisers in Baghdad. They play a significant role in communications, logistics, and operational planning for Baghdad."

Then, to complete the complicity in this planned war, the Soviet military command sent a Colonel General Albert Makashov to Iraq on July 17, 1990, just two weeks before the invasion. He stayed in Iraq through the invasion and departed for Russia on August 13, which was eleven days after the invasion. When he returned to Russia, he reported directly to the Soviet Military intelligence and not to President Gorbachev.

General Makashov is very close to Marshall Ogarkov, the head of the Russian military machine. Marshall Ogarkov is known to have formulated and implemented a new, grand strategy for the Soviet Union which states that they can achieve victory without a single

nuclear weapon being fired. Marshall Ogarkov is known to be a master of strategic deception, camouflage and concealment. It is apparent that General Makashov went to Iraq with that type of information and instruction.

Now for the grand double-cross. It was after Bush attacked Iraq with the airstrikes and cruise missiles, not before, that the Russian military started in earnest the martial law tactics and the brutal crackdown on the Baltic dissenters. Further, Russia has made it known that they do not approve of the massive air strikes on Iraq. President Bush still thinks that he can pull off his "new-world order" because the international money lenders still has some measure of control over Russia. However, as soon as the current transformation of Russia from a Communist society to the return of an Imperialist society is secured, the relationship with the Zionist West will once again vanish.

We have in our files substantial evidence that the Jews of Russia are very concerned that the "Pogroms of Russia" will return in the near future. In simplistic terms, the pogroms are concentration camps very similar to the concentration camps of the Boar War in South Africa, the concentration camps for the Japanese under Roosevelt in World War II and the contemplated concentration camps in the United States for dissidents during the time of martial law.

In the meantime, we as a nation, are becoming more and more the "great satan" of the world for systematically grinding up Iraq and its people like so many pounds of hamburger. While an increasingly larger part of the world is showing its disgust and disdain for the massive bombings, our government at the highest level is calling it a just and righteous war.

We must never confuse what our troops are doing with what our government is doing. Our servicemen are doing an outstanding job and our hearts must go out to them and to their families. We must have the greatest empathy and heartfelt warmth for the families who have loved-ones over there. We must never, never hold them responsible for the actions of our government like was done during the Vietnam war.

But it is time we hold the government itself accountable for its actions. It is time we put a stop to the government having secret conspiracies and making secret deals with foreign countries and the government within the government here at home. It is time that we put a stop to the propaganda machine that tells us that all of these secret deals are accomplished for "security" reasons. Who are they afraid will learn about these little secret conspiracies? It is not the other countries because they are a part of the secret. It has to be kept secret from us, the American people. All that they want us to do is to pay for all of their machinations.

As examples of the secret deals, conspiracies and propaganda of this "nice little war" to bring in the "new-world order," the *Spotlight* newspaper reports that Israel has been allowed from the very outset of the air bombardment of Iraq to fly a secret air corridor over Syria to bomb selected targets in Iraq. Their F-14 and F-16 fighters obliterated the small town of Tikrit in Northern Iraq. This is the birthplace of Saddam Hussein and has no military value whatsoever. It is estimated that over half of the 24,000 inhabitants were killed by the Israeli planes. Further, the planes had American markings on them according to the newspaper report.

Further, the ancient Biblical town of Nineveh was bombed. The Amman, Jordan newspaper *Opinion* reported that the ancient St. Toma Cathedral in Nineveh, built in the first century, was destroyed.

Additionally, the Egyptian journalist, Anwar Halimi, reported that the ancient Chaldean Christian cathedral in the Old City of Bagdad was destroyed. He reported, "That church was a cherished cultural treasure of all mankind. It has now been smashed to bits, along with the abodes, possessions and simple lives of more than 100,000 Iraqi civilians. If there will actually be war crimes trials in the aftermath of this war, the wanton bombing of Iraq's population and priceless cultural treasures may well form the most searing indictment."

The propaganda mill reminds us that we are not targeting the civilian population and our "smart bombs" can strike a military target, destroy it and leave an adjacent civilian building intact. This is true and is demonstrated repeatedly on TV. However, what about the carpet bombings, by B-52's and other types, from an altitude of sometimes over 25,000 feet because of weather or anti-aircraft fire? This is the same type of bombing that destroyed the cities of Germany, including the massive bombing of the Christian refuge city of Dresden, during World War II.

The propaganda mill also reports to us that Hussein has an elaborate underground fall-out shelter which is nuclear-proofed and very comfortable. The statement is made in such a way as to prove how detestable Saddam Hussein really is. Maybe so but what about the very elaborate underground city cut into the solid rock of Weather mountain just outside of Washington, D.C.? This is built, not to save the taxpayers who paid for it but for those same leaders who made the conspiracies and secret deals to get us into the war with Iraq. It could be that we don't understand the word detestable!

"Israel will need at least \$13 billion in additional economic aid from the U.S. because of the gulf war and to absorb the Jews from the Soviet Union." Yitzhak Moda'i, the Israeli Finance Minister, recently made this statement to his co-conspirators in Washington. This is a perfect example of *chutzpah* (Yiddish for brazen, self-centered and insulting).

Ten billion is to pay for the resettlement of the Soviet immigrants. Remember, these immigrants are being allowed to go to Israel because of the conspiracy to justify taking over Jordan. Three billion is to pay for their loss in economic output because of the United States' war with Iraq. It is obvious that they justify this by thinking that it is the conspiracy of Britain and the United States (without mentioning the partnership with international Zionism) that is using the Iraqi war as the catalyst to bring in the "New World Order."

Remember, a large portion of their economic output and the loss in export orders comes from the sales of military hardware and ammunition to third world countries. We must also compare their increased insurance payments and the loss in property because of the Scud missiles with what would happen here in our country. There are very few, if any, insurance companies here in the United States that will pay for damages as a result of war or insurrection. That means that, again, the American citizen would have to pay for his own damages.

[The American Israel Political Affairs Committee](#) (AIPAC) is already pressuring congressmen and senators to approve of this request for blood money. That is *chutzpah*, to be a part in the conspiracy to take over the country of Jordan, to create Genocide on the Palestinian people and have the American taxpayer pay for it.

Weapons Confiscation

The legislature of the state of California passed a law making it illegal to possess certain types of semi-automatic weapons. The date for the mass submission of weapons was to be January 1, 1990. To date the response has been very low with only a comparatively few weapons turned in. This has been tried in other parts of the country with equal results. We

must praise God that he has put it in the hearts and minds of Americans that this is our "line drawn in the sand," beyond which we will not back up.

In keeping with this God given, constitutional, mind set, the following letter to his U.S. Senator was written and first published in the *CBA Bulletin*, P.O. Box 935, Medford, OR 97501.

"To: Senator Wilson, The Capitol, Washington, D.C. 20515. I am not a member of the KU Klux Klan. I am not a member of a drug gang. I am not a member of a neo Nazi group. I am not insane and I am not a felon. BUT I am a gun owner and I am going to tell you why I own several of the guns that I `keep and bear."

"What I am going to tell you is not going to make you comfortable. But then, much of the power you and your colleagues wield does not make me comfortable. It isn't my hand that hovers over `the button.' It isn't me who controls the vast armies of police and soldiers in this land. It isn't my order that can send droves of rocket armed helicopters towards any target outside or inside this country. Senator, it isn't my hand that can end all life on earth!"

"Let me be blunt. The time for `pussy footing' around this subject has long passed. I own a sem-automatic rifle so that I may SHOOT AND KILL a tyrannical police officer, a brainwashed soldier, a corrupt judge, or a treasonous politician...IF that horrible and sickening necessity ever arises in my life here in the United States of America. Unless one has a grounding in the philosophy and thought of the Founders of this Nation, the above statement smacks of the highest level of sedition. Don't distort my intent. And don't necessarily take it personally. I believe you respect and cherish the Constituion...after all, you swore to me and all America that you would. I'll take your word. But you must DEMONSTRATE your loyalty to that oath!"

"Someone I know suggested that we send the following single message to every politician, police officer, judge and soldier in the country: `Obey the Constitution of the United States of America and we won't shoot you."

"A harsh and raw message isn't it Senator? It sounds like something some American back in 1795 might have uttered doesn't it? I wonder how many tens of millions of American citizens might agree with these sentiments right now, today? Believe me when I tell you that the recent un-Constitutional activities of our law makers is squeezing this sentiment up from within us like some bitter juice."

"YOU WILL NOT TAKE OUR GUNS AWAY." Our right to keep and bear arms is our last, desperate `check and balance.' Yes, guns are for KILLING PEOPLE if the need arises. Why do we pretend otherwise? May God guide you in your future decisions. Stay on the side of `We the people...' Sincerely, Sanely, Lawfully and Constitutionally, Kirby Ferris, Stinson Beach, California."

We would be very pleased to send to those who actively participate in this ministry, a very well written pamphlet titled *Get America Up In Arms* by William P. Fall. This document outlines the history of the Second Amendment and it includes the Supreme Court's decisions through the years regarding the right to bear arms. The Supreme Court decision as recent as the World War II era explicitly implies the use of automatic type weapons.

Lesson In History Part 12

To be sure, these lessons in history should be most convincing, to even the "doubting Thomases" among us, that there has, indeed, been a conspiracy throughout our history. It has been pointed out on several occasions in these lessons that the conspiracy isn't of the type where a few men meet in a secret place and plot a singular event to overthrow one system for another. The time period for this grand conspiracy has been too long for that. This great conspiracy was perpetrated and conducted down through the years by people with a common purpose and with a common mind set.

When we have completed the series, we will have realized that this conspiracy actually began long before Christ's birth. We will also have learned that the ultimate underlying motive of the conspiracy is to create a world with one religion, one government and one people. The one people concept was simply explained when Billy Graham publicly stated not too many years ago, "Won't it be nice when we are all a nice, light shade of brown." To show that these conspirators (people with a common mindset) communicate and visit with each other, we are reminded of the recent overnight visit of Billy Graham with President Bush in the White House. Of course, President Bush has repeatedly stated his position of the one-world government so both of them are co-conspirators and whether they know it or not, they are opposing God's will and purpose for all of us here on earth.

The one-world religion has also been attempted many times before and God has always put a stop to it. We will thoroughly cover that later in the series.

In this lesson in history we will study that part of the conspiracy that proposes a one-world people concept as it pertains to our country. In secular terms it is called "The Immigration Policy of the United States." Just as Paul, in [I Corinthians 12](#), admonishes us as to the oneness of spirit in the Body of Christ, those in the great conspiracy also know of the power of oneness of spirit. Each of them throughout the years has methodically plodded forward with their one-world people concept. To them, it is called "the brotherhood of man."

Their leaders also know that the Principles and Laws of God are inviolate. If we can be taught that those Principles and Laws are no longer in force, their new tower of Babel is assured. Consequently, high on the agenda of the conspirators was to infiltrate the Christian Church. Two scriptures comes to mind immediately. *"My people are destroyed for lack of knowledge: because thou hast rejected knowledge, I will also reject thee, that thou shalt be no priest to me: seeing thou hast forgotten the law of thy God, I will also forget thy children."* ([Hosea 4:6](#)) Also, *"O Israel, thou hast destroyed thyself; but in me is thine help."* ([Hosea 13:9](#))

The Principles and Laws that we have disregarded in our one-world people, or immigration policies, of the United States are found in the books of Genesis, Exodus and Deuteronomy.

In [Genesis 3:17-19](#) we read this, *"And unto Adam he said, Because thou hast hearkened unto the voice of thy wife, and hast eaten of the tree, of which I commanded thee, saying, Thou shalt not eat of it: cursed is the ground for thy sake; in sorrow shalt thou eat of it all the days of thy life; Thorns also and thistles shall it bring forth to thee; and thou shalt eat the herb of the field; In the sweat of thy face shalt thou eat bread, till thou return unto the ground; for out of it wast thou taken: for dust thou art, and unto dust shalt thou return."*

What God told Adamic man was that he was to do his own work and that it was going to be hard enough for him to sweat in the face doing it. That is not to say that one man cannot hire another to do work but he is to pay him commensurate with his work. *"For the labourer is worthy of his hire."* ([Luke 10:7](#)) God forbid Adamic man to utilize the other peoples for either slave labor or cheap labor at twenty-five cents per hour like we have done in the past

in this country and like we are doing now by the multi-national corporations in the third world countries.

The second scripture for the Principle involved is found in [Exodus, chapter 22:21](#), "*Thou shalt neither vex a stranger, nor oppress him: for ye were strangers in the land of Egypt.*" That means that on those occasions when a racial alien does work for us as a sojourner who is passing through, but not a permanent citizen, we are not to maltreat him nor enslave him.

The third scripture involved is found in [Deuteronomy 28:43](#), "*The stranger that is within thee shall get up above thee very high; and thou shalt come down very low.*" When we fail principles one and two above, this third principle will befall us. These principles are so inviolate that God says, "*And it shall come to pass, that as the Lord rejoiced over you to do you good, and to multiply you; so the Lord will rejoice over you to destroy you, and to bring you to nought; and ye shall be plucked from off the land whither thou goest to possess it.*" ([Deu 28:63](#))

The Christian fathers among the early leaders of our country knew these principles very well and it was their intention that the United States of America be stocked with immigrants from Christian Western Europe.

The original law to regulate immigration into the United States was enacted a short three years after the ratification of the Constitution. On March 26, 1790, the "Act to Establish an Uniform Rule of Naturalization" was enacted. The law provided only for the absorption of "any alien, being a free white person, who shall have resided within the limits and under the jurisdiction of the United States for the term of two years." On January 28, 1795, a revision of that original law required five years of residence in the United States, and also insisted that the prospective citizen renounce allegiance to all other powers at least three years before presenting himself for citizenship here. Anything like the dual citizenship with Israel that we have today would have been outlawed.

We must differentiate between the Principles of God as found in the verse quoted in Exodus with that found in Deuteronomy. Judgment always comes to us when we open the door to pluralism and the "melting pot" philosophy in order to obtain cheap labor.

Perhaps the best way to express the convictions of our forefathers is to quote from the book *Sentiment or Survival: Crisis in the Immigration Policy of the United States* by M.E. Bradford, Ph.D.

"Even in the most ancient literature of the (Adamic) West, hospitality to travellers and visitors is recognized as the virtue which distinguishes civilized men....According to the teaching, to offer the wanderer safe harbor is to deserve the same, should exile ever be our misfortune. "Hospitality is an expression of the self-esteem, the spirit of *noblesse oblige*, to be found among a proud people. It is not a measure of self-interest but of sentiment, reflecting a powerful sense of security and grace. But self-respect has nothing to do with a suicidal passion to `open the gates and let them all come in.' For the first law of every society, even the condition of its gestures of generosity, is that it puts the needs of its own members ahead of the needs of outsiders. Such an order of priorities is part of what we mean by the `social contract,' the commitment to certain persons by the terms of which we are precluded from establishing an equivalent bond with others. Said another way, any act of choosing is an act of exclusion as well as of inclusion. We have no social connection with any man if we have the same obligations to all." [1](#)

Our forefathers realized this ancient knowledge because they read those masterful books. They recognized the problems associated with negro slavery. The system of slavery

had been forced upon us long before the War for Independence by the international money barons, the Yankee traders like the Boston Brahmins, the Kings of England (who owed the money barons) and last but not least, the desire to obtain cheap labor in direct violation of [Genesis 3:17-19](#). As we become more affluent we become lazy. As we become lazy we permit the stranger (racial alien) to take over. The cycle repeats itself.

As a young nation, we tried to correct the slavery problem. The American Colonization Society, under the Presidency of James Monroe (1817-1825), developed a program to expatriate the Negro back to his native land in Africa. Many prominent Americans supported this organization and Congress itself funded the organization with \$100,000. The country of Liberia in Africa was selected as the country of colonization. In spite of wide spread support it was never really successful with not more than 12,000 slaves being returned.

George Washington, Thomas Jefferson, James Monroe and a host of other leaders recognized that slavery was wrong and that in keeping with the teachings of the Bible, as well as the writings of the ancient Adamic civilizations, the only solution to the problem was to expatriate the slaves back to their native countries.

During the beginning years of the 19th century, the young nation was divided over the question of whether the Negro should be brought into the nation with full membership or should they be returned to Africa. The Christian Churches, as with nearly everything else, was equally divided. It was again the Cromwellian conspiracy, starting in England in the middle 17th century which combined the forces of the International Jewish Money Lenders with the nobility of England, that strove for the inclusion of the slaves into mainstream America.

The conspiracy is there to understand by careful research in the history of those years leading up to the Civil War and just beyond. That conspiracy was centered around the abolition movement and was financed by the same people that financed Cromwell. That conspiracy worked within the churches, the political arena and the universities.

The liberal presses printed tons of propaganda. *The Liberator*, a newspaper published by William Lloyd Garrison as well as another publication, the *North Star*, printed by Frederick Douglass in 1847, was used to sway the minds of Americans from expatriation to pluralization.

Why did and do they have the idea of "the brotherhood of man?" The answer is simple. If they can reduce the entire population on earth to the lowest common denominator, all the while keeping their select few separated and intact, they think they can rule and own the whole world.

The concept that the solution to the problem was to expatriate the Negro back to Africa suddenly stopped at the time of the assassination of President Lincoln. The conspirators had won the battle. All that was needed was to establish the necessary amendments to the Constitution to legalize it.

First, the [13th Amendment](#) was proclaimed and made a law of the land on Dec. 18, 1865. This Amendment only ended slavery, it did not make the Negro a citizen. The [14th Amendment](#) was proposed in June, 1866 and proclaimed a law of the land on July 28, 1868 even though it was not properly amended.

President Lincoln had gone on record that the ten Southern states had never legally left the Union. Eight of the ten Southern states had ratified the [13th Amendment](#), along with the other State Legislatures. However, the Republican Party controlled Congress and in Dec. 1865, refused to seat the elected members of the Senate and House of Representatives

from the ten Southern States. The reason for this refusal on the part of the Republicans was that they thought the ten Southern States would block the ratification of the [14th Amendment](#) which made citizens of the freed Negroes. Of course, as soon as the ratification process was over, the Congress brought the ten Southern States back into the Union for compliance. It can readily be seen why there are very few Republicans among the old families of the South to this very day! [2](#)

The history of the [13th](#) and [14th](#) Amendments is but another example that there is indeed a conspiracy to destroy the genuine Christian civilization of America. The "Golden Years" of America of the 1820's and 1830's had to be destroyed and they used the plight of the Negro to change the concept of the immigration policies of the United States. They didn't care one iota for the Negro any more than they did for you and me. The [13th](#) and [14th](#) Amendments allowed for all of the so-called "Civil Rights" legislation that has been enacted since. All of this legislation has been to create a "New World Order" and paramount to that order is a "one-world people." Since the United States at that time was the shining example of government, it was here that the change had to start.

Following these actions on the part of the Congress in concert with the conspiracy, the doors were wide open for immigrants from all over the world. The Christian people from the Celto-Saxon countries of Europe made their last, great immigration into America during the years just before the Civil War and the changes that took place as a result of the [13th](#) and [14th](#) Amendments. During the years 1840-1860 almost 4,400,000 people crossed the seas to become Americans. They came from Ireland, the United Kingdom and Germany, all Christian and Celto-Saxon.

However, after these two infamous Amendments to the Constitution, a profound change took place in the concepts of ethnicity within the nation. Again, because of greed, love of money and in direct defiance to God's command to Adamic man as found in [Genesis 3:17-19](#), hordes of Chinese Coolies were imported into the country to work on the railways being built by the railroad barons. The story of greed, exploitation of land and resources and the haphazard workmanship of the first railways is a story unto itself. After the agreements were met with the government in building the railroads, the railroad barons were given huge tracts of land throughout the Midwest and West. They then could speculate with that land and, as a result, controlled the politics of the frontier to a great extent. But most important for this study, when they were through with the Chinese Coolies, they dumped them in San Francisco.

Moreover, after the Civil War and after the two amendments, the pattern of immigration from the European and Asian Continents made the most drastic change. During the period between 1865-1915 the immigration brought in over thirty million (30,000,000) people, mostly from the Eastern countries and Russia. It was during this period of time that the Statue of Liberty was built, a gift of France. Ellis Island was built to receive this horde from Russia and Asia. The words of the Jewish poet Emma Lazarus was inscribed on the base which, we now realize, was of significant importance.

One of the traits, good or bad, of the Celto-Saxon is that he is slow to anger and to become alarmed. It was not until the 1880's that he started to fight back. One of the first signs of a shift in the nation's attitude against this new pluralism was the Chinese Exclusion Act of May 6, 1882. In 1885 there were provisions which banned the entry of prostitutes and criminals. The 1882 Act provided for the exclusion of the diseased, the socially undesirable, paupers without resource and the mentally defective.

The 1882 Immigration Act truly tried to reverse the trends that the [13th](#) and [14th](#) Amendments forced upon the nation. The Act looked toward the repatriation of numerous

unwanted aliens. It was followed by statutes forbidding overseas recruiting of contract labor and similar practices. It also required that the prospective immigrant be literate in some language.

All of this legislation was the realization by Congress that its first priority was to have long-term stability and survival of the United States nation as a people of European Christians. They did the best they could under the restrictions of the two infamous amendments. They finally wrote the Quota Act of 1921 and the momentous Immigration Act of May 26, 1924. These Acts provided for a quota by national origins and an overall limit on annual admissions. Asians and Africans were not allowed. The American people were tired of "The Melting Pot" and "Yearning to be free."

But that didn't stop the conspirators, those whose primary design was to destroy the Christian faith and to further "the brotherhood of man." Between the two World Wars, a small but very vociferous and persistent group of federal legislators advocated sweeping reforms to the immigration laws enacted between 1882 and 1925. Two men in the House were most prominent in this reform movement. They were led by Isaac Siegal (R-N.Y.) and Adolph J. Sabath (D-Ill.).

This group took maximum advantage of the circumstances in the United States at the time. There was the great depression. The Jews had declared war on Germany and our government recognized this action. This in itself caused many families with German names to change their names to escape the persecution they knew would come based on the horrible conditions in the Weimar Republic in Germany. The incessant propaganda of the American news media caused most citizens with a Celto-Saxon heritage to be either embarrassed or intimidated.

The Chinese Exclusion Acts were repealed in 1943. The Indian Exclusion Act was repealed in 1946. President Truman, a 32nd degree Mason, gave another "give them hell-Harry" message when Congress introduced the McCarran-Walter Act. Senators Herbert H. Lehman (D-N.Y.) and Herbert Humphrey (D-Minn.) tarred the proposed Act with epithets of "Nazi" and "racist." The New York Times wrote near-hysteria editorials. Even though the Act was somewhat conciliatory, it wasn't enough for the conspirators. However, the Act passed and became a law in 1952.

Eisenhower spoke in favor of restricting immigration when he ran for office but as soon as he was elected, he espoused the viewpoints of Sabath, Siegal, Lehman, Humphrey, Truman and all the rest and the immigration of non-Europeans increased to the levels of before 1920.

There was a total disregard for the provisions of the McCarren-Walters Act by Eisenhower and various Congressmen and this was due to the extremely strong pressure placed by the newly franchised Americans, particularly from Khazaria in Russia. A person was a racist, a Nazi and an anti-semitic if he opposed this drive for the pluralism of America.

President Kennedy continued the assault on the McCarren-Walters Act and at the same time disclosed the "New World Order" drive by the conspirators when he also proposed the abolition of the national-origins system. He stated, "We need to realize humanitarian objectives in an age of interdependence among nations."

Then in 1965, under the cajoling of President Johnson, 145 years of continuity of immigration laws in the United States ended when Congress overwhelmingly passed a law repealing the existing laws.

The final assault on America's heritage has begun. Christianity itself is reeling under the onslaught in America. The predictions of Edward Gibbon in his *Decline and Fall of the Roman Empire* and Oswald Spengler in his *Decline of the West* haunts us.

But it is not too late, brothers and sisters, it is not too late. *"If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land."* ([2 Chron. 7:14](#))

Wilmot Robertson in his brilliantly written book *The Dispossessed Majority* discusses the deprivation of the Celto-Saxon majority in the United States. He also shows that the phenomena is extant in all of the Celto-Saxon countries, not just the United States.

He discloses that the solution is nearly hopeless because of the modern day technology of the Babylonian system. He shows that for the European, Teutonic Celto-Saxon to survive, he must utilize a most unique technique. Here, in a very abbreviated form, is his proposal:

"...America's... Majority must look for deliverance and regeneration to the defenses of the mind. There will be no end to its dispossession until the Majority learns to reject ALL the main currents of modern liberal thought....The absurdities, fallacies and contradictions of Marxism, Freudianism, the equalitarian anthropology of Boas and contemporary socialism are not important in themselves. What is important is how and why they have been developed and synthesized into the most unbending intellectual absolutism since medieval scholasticism..."

"The Pax Americana (American peace-ed.), its primary task the consolidation, security and advancement of the Northern European peoples, would be the first world order whose geographical frontiers corresponded to its racial frontiers. Such a genetically-based, intercontinental confederation, a radically new way of bringing a scattered people together, might overcome or alleviate some of the dangers to mankind which the crypto-racism of the proletarian politics seems to multiply...There would emphatically be no place for the old-style exploitation of nonwhites nor the forcible adaptation of autochthonous (aboriginal, indigenous, native-ed.) civilizations to Northern European cultural norms."

"But everything hangs on the fate of the American Majority. If its dispossession is not stopped and reversed, there will be no Pax Americana, no halt to the decline of the West, no giving the lie to Spengler. In fact, there will soon be no America. History is insistent in pointing out that when the dominant population group goes, the country goes. As is daily becoming more apparent, the dying fall of the American Majority is the dying fall of America itself." [4](#) End of quotes from Mr. Robertson's book.

What Mr. Robertson is saying is that we must reject all of the gods of Mystery Babylon partially represented by Marxism, Freudianism, Boas' anthropology of equality and social democracy. He is but quoting Paul in [2 Cor. 4:2](#) when he said, *"But have renounced the hidden things of dishonesty, not walking in craftiness, nor handling the word of God deceitfully; but by manifestation of the truth commending ourselves to every man's conscience in the sight of God."*

It must start with the Remnant, not the Majority. That appears to already have begun. All over the world the Remnant is moving. In Russia, the Balkans, Germany, France, England, South Africa, movements are forming which are reasserting the right of the Celto-Saxon to exist and to have his culture, mores and civilization.
