2. Assessor's Audit: Paul met with Randy . All 7 items cited on the audit were addressed and documented.

NEW BUSINESS:

1. Recreation Plan: Hillary Galarowic informed the board that the Rec. Plan has to be available for public viewing for 30 days. The January 12th meeting will open with the 1st agenda item being the Rec Plan.

FIRE REPORT:

1. Bruce reported that there were no runs for November.
2. Received donations of \$250. from AMVETs and \$300 from RASC for the RTVFD Children's Fund. The Children's Christmas Party with Santa will be Thursday, Dec. 17th 6pm-7pm with Cookies and Hot Chocolate. Emily and Sierra will make the cookies in the hall kitchen, and Sherry will do up posters. There was discussion on adding hats/mittens to the toy list.

3. Snowmobile Race: Is scheduled for February 27, 2016 at the Postula Farm (same as last year). and tentatively scheduling a vintage race with studded tracks on the bay for March 12th.
