

**HAMPTON TOWNSHIP
FULLY FUNDED ORDINANCE #2018-18**

**A FULLY FUNDED ORDINANCE APPROPRIATING THE SUM OF \$220,000.00 FOR
IMPROVEMENTS TO KEMAH MECCA LAKE ROAD SECTION III TO BE FUNDED
WITH A GRANT RECEIVABLE FROM THE STATE OF NEW JERSEY
DEPARTMENT OF TRANSPORTATION FUND IN THE AMOUNT OF \$220,000.00**

WHEREAS, the Township of Hampton received a grant in the amount of \$220,000.00 for the purpose of improving Kemah Mecca Lake Road Section III.

NOW, THEREFORE BE IT RESOLVED by the Township Committee of the Township of Hampton, Sussex County and the State of New Jersey that there shall be appropriated the sum of \$220,000.00 from a grant receivable from the State of New Jersey Department of Transportation.

SECTION 1. There is hereby appropriated the sum of \$220,000.00 for improvements to Kemah Mecca Lake Road Section III from a grant receivable from the State of New Jersey Department of Transportation.

SECTION 2. All Ordinances or parts of Ordinances, which are inconsistent with the terms of this Ordinance, be and the same are hereby repealed to the extent of their inconsistency.

SECTION 3. This ordinance shall take effect immediately upon proper passage and publication in accordance with law.
