Minutes of *Ellsworth Zoning Commission* Regular Meeting Held *February 14, 2017* 

On Tuesday, February 14, 2017, the Ellsworth Township Zoning Commission's regular meeting began at 6:00 PM at the Fire Hall.

Chair Sean Giblin opened the meeting leading with the Pledge of Allegiance followed by a moment of silence for those serving our country past and present.

Members present were Chair Sean Giblin, Vice Chair Jim Mayberry, Janine Goddard and Dan Stout. Excused is Alternate Jerry Matteucci.
