AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF CISCO, TEXAS AMENDING CHAPTER 2 "ADMINISTRATION", SPECIFICALLY ARTICLE III "PLANNING AND ZONING COMMISSION", SECTION 2-42 "MEMBERSHIP AND APPOINTMENT", SECTION 2-43 "TERMS OF OFFICE", AND SECTION 2-46 "MEETINGS AND QUORUM" OF THE CITY'S CODE OF ORDINANCES, MAKING THE ALTERNATE MEMBERS OF THE COMMISSION FULL MEMBERS, AND AMENDING PLACE NUMBERS, TERMS OF OFFICE, AND QUORUM REGULATIONS TO REFLECT SUCH; AND ESTABLISHING AN EFFECTIVE DATE.—*First Reading*
