January 23, 2019 in Hanford, CA



Dairy Farmers of Canada Board Member David Janssens, a dairy farmer from British Columbia, will serve as keynote speaker during the upcoming California Dairy Campaign and California Farmers Union Joint Annual Meeting in Hanford set to take place on January 23, 2019. In addition to our

David Janssens plans to speak about how the Canadian dairy supply

management system ensures a stable and fair milk price to dairy farmers. Given that milk prices in Canada are nearly twice as high as California milk prices, California Dairy Campaign is encouraging dairy producers, dairy leaders and lawmakers to look to the Canadian system for solutions to the crisis US dairy producers face today. Already dairy farmers in Wisconsin and Michigan have held regional meetings with dairy farmers from Canada to provide details about the Canadian dairy inventory management program to serve as a model for policy changes to US dairy policy.

Milk prices paid to dairy producers have been well below production costs for more than four years, causing dairy producers to go out of business at an alarming rate. Over the last 10 years, more than 600 dairies have gone out of operation across California leaving less than 1300 in the state today. The 30 percent drop in the number of dairies in California is consistent with the decline in the number of dairy farms nationwide.

California Dairy Campaign and California Farmers Union are proposing the **Sustainable Milk Inventory System Act (SMISA)** a three-point plan to foster a strong and sustainable dairy system in the United States. The three-point plan includes:

- 1. Inventory management
- 2. Fair milk prices paid to dairy farmers
- 3. Effective dairy trade policy

To address the nationwide dairy crisis, California Dairy Campaign and California Farmers Union leaders have been participating in a nationwide effort in support of inventory management along with dairy farmers from Wisconsin Farmers Union and many other states called *Dairy Together* to provide solutions to the dairy crisis caused by chronically low milk prices. The nationwide effort open to all dairy farmers began last spring to bring dairy producers from around the country together in support of dairy inventory management. Support for dairy inventory management is growing as more dairy farmers learn about how a farmer-led inventory management plan can better match milk production with market demand, improve milk prices paid to dairy producers and sustain dairies nationwide.
