PRESIDENT'S REMARKS

"Shelter in Place" gets old in a hurry, but the alternative is far worse, so better we continue to limit our exposure to others. As we stated in the last newsletter, all HOA activities have been suspended, even the book exchange. Our pool contractor has been in contact with the County and will let us know when the County will allow us to reopen the pool.

You may have heard that some animals have now contracted Covid-19 (Tigers and domestic cats so far) which has resulted in some pet owners wishing to have their animals adhere to "social distancing". Please make sure while out walking your dog to get permission first from others before your pet races over to greet their dog.

Mike Dietrick has decided he no longer wants to serve on the HOA Board of Directors so we invite anyone who is interested in serving to let one of the board members know of your interest. The Board thanks Mike for all his outstanding contributions to Chantarelle. At some point we will appoint a new board member.

The Board agreed to handle the annual backflow testing mandated by the State. By having a contract for all the homes it saves you almost 50% and you don't have to worry about contacting the contractor and the water district. Ignore any letters from VOMWD or backflow contractors, we will take care of the work.

FINANCIAL REPORT

Treasurer's report thru the end of March

The Covid-19 crisis and subsequent stay-at-home restrictions have caused a lot of tragedy and hardship in Sonoma and around the world. One very small positive that has resulted from this, however, has been on the HOA finances, particularly the utilities category, which is below budget due to closing of the club house. We might expect a similar impact regarding the pool, which did not open as usual in April. The new opening date remains unknown at this time since it will depend on when the shelter-in-place restrictions are relaxed by the county. As for the other budget areas, we are under budget in all but one category, that one category being General and Administrative costs. We are still over budget due to having paid our liability and bond

insurance premium for the full year. However, this category should even out as the year progresses. In summary, for total expenses, we're under budget through the end of March by about \$9,200. Also, our operating cash position was about \$74,000. After deducting current liabilities of about \$10,500, we had a liquid cash position of about \$63,500, which should be sufficient to cover any surprises in the next few months. One area of concern is delinquent dues owed by several homeowners and which will be addressed by the board and the Management company in the upcoming month.

Hello neighbors. We are still on lockdown, so there is not much to report. The Waldron crew continues to maintain the property. Please minimize contact with them to comply with social distancing rules.

Please keep an eye on your own plants, we have a lot of aphids right now. Maybe it has to do with less human presence and pollution.

REMINDER TO OBTAIN ACC APPROVAL

Exterior changes to homes, windows, fences, garage doors, paint colors, gates or roofs must be approved by the **Architectural Control Committee** (ACC) BEFORE work begins. Request forms are available in the clubhouse, online at Chantarelle.org, from ACC committee members and from Strong Management. Completed forms must be submitted to the ACC at least 30 days before the start of the project to allow time for review and follow-up. When projects involve common area fences shared by both the homeowner and the HOA, additional procedures mentioned in the May 2012 "Report on Common Area Fences" must be followed, including obtaining multiple bids. An additional item has been added to the ACC approval process regarding the display of flags. The American Stars and Stripes, individual

state flags, and seasonal/holiday flags may in most cases be flown without permission. Permission to fly other flags must be requested from the ACC. Adhering to ACC rules will ensure the continued coherence and beauty of the Chantarelle community, while at the same time maintaining the quality of life and desirability of residing here.
