2) Booth orientation along with dimensions for drop and air outlet locations; please provide surrounding aisle and/or booth numbers, particularly for island booths. In addition, please try to orient your booth to the overall floor plan so that the diagram does not have to be rotated.
3) Please include the connection size and total CFM's required for all air outlets, provide the total amount of gallons for all fill \& drains.
