

**AMELIA VILLAGE, OHIO ORDINANCE: O-2013-56**

**AN ORDINANCE BY THE COUNCIL OF AMELIA VILLAGE, OHIO REPEALING ORDINANCE O-2013-55, AND MAKING SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES & OTHER EXPENDITURES FOR THE FISCAL YEAR ENDING DECEMBER 31, 2013 FOR AMELIA VILLAGE.**

**WHEREAS**, the Village is required by statute to prepare and adopt annual permanent appropriations of Village revenues for current expenses and other expenditures for the fiscal year ending December 31, 2013;

**WHEREAS**, on March 12, 2013, Village Council adopted ordinance O-2013-13 authorizing the permanent appropriations for current expenses and other expenditures during fiscal year 2013; and

**WHEREAS**, on November 12, 2013, Village Council adopted ordinance O-2013-55, making supplemental appropriations for current expenses and other expenditures; and

**WHEREAS**, there was an error in the appropriation amounts of O-2013-55; and

**WHEREAS**, Council desires to correct the supplemental appropriations which are necessary at this time, to provide for the current expenses and other expenditures of Amelia Village during said fiscal year.

**NOW THEREFORE BE IT ORDAINED** by the Amelia Village Council as follows;

**SECTION I** Ordinance O-2013-55 is hereby repealed, as an incorrect amount was recorded as an appropriation during the fiscal year ending December 31, 2013.

**SECTION II** It is necessary to provide for additional expenditures of Amelia Village during the fiscal year ending December 31, 2013.

**SECTION III** That there be appropriated from the Parks & Recreation Fund Fund:

**SECTION IV** Village Council finds these supplemental appropriations are necessary to provide sufficient funds for the several obligations of the Village.

**SECTION V** the Village Fiscal Officer is hereby directed to make the supplemental appropriations as outlined in this Ordinance.

**SECTION VI** This Ordinance shall take effect and be in force at the earliest time allowed by law.

**SECTION VII** The Amelia Village Council finds and determines that all formal actions relative to the passage of this ordinance were taken in an open meeting of this Council, and, that all deliberations of the Council and of its committees, if any, which resulted in the formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.




