Guest speaker Joe Mazzola Health Commissioner from the Franklin County Board of Health addressed the board and audience.

The Franklin County Health Department works hard to serve everyone's needs in a variety of ways. There are low cost immunization clinics for residents, and rabies clinics for dogs, and cats. These dates, times and locations are available in the township lobby or online at www.myfcph.org.

Health department is working on mosquito trapping in all areas of Franklin County and has no west nile to report so far. Residents are encouraged to be proactive at home by removing standing water and places where mosquitos can breed.

The health department is working on a new action plans to combat the opiate epidemic. Chief Adams has been working hand in hand with the health department and has been able to get NARCAN for the fire department at no cost. Franklin Township fire department uses NARCAN daily for overdose victims. Franklin County Health Department is working to get unused prescription medication disposed of properly to stop abuse of medication. Franklin Township accepts expired or unused prescriptions during normal business hours.

Coming up in the near future the Franklin County Health Department will be holding "Community Health Assessments" to hear from residents in communities what their needs are. These dates, times, and locations will be available soon online at www.myfcph.org.

Chief Adams gave update on stats for May 2017; 783 EMS Runs and 96 Fire Runs.

Fire department is installing smoke detectors for anyone in the township that is interested. You can call 614-279-9411 and give your name, address and phone number and Chief Adam's will return your call to schedule an installation. 86 smoke detectors have been installed so far at no cost to residents or the township.

June 10, 2017 the fire department will be out knocking on doors in the N Hague, Fisher Rd, and Broadlawn area offering smoke detector installation.

Mid July the fire department will be in the southern part of township installing smoke detectors.
