# Lakewood Forest Civic Association Meeting Minutes – July 18, 2023

The monthly meeting of the LFCA was called to order at 7:07 pm by president Jodi Cole. Other board members present were Scott Johnson, Jamie MacKeen, Terri Cole, Lori Estepp, Andrea Lightcap, and Linda Musthaler.

#### Minutes

The minutes from the June 2023 meeting were reviewed. Scott J. made a motion to accept the minutes pending a minor change. Terri C. seconded the motion and it passed unanimously.

#### **Treasurer Report**

Scott J. provided the monthly financial report for June. As of June 30, 2023, we had \$30,333.11 in total funds. There is \$10,482.27 in the checking account, with one outstanding check in the amount of \$4,672.50. We issued seven checks in June totaling \$6,161.68. The money market account has a balance of \$9,535.11 and the 12-month CD has a value of \$5,643.23.

In comparing the budget to actual expenditures as of end of June, we have a deficit of \$6,121 because Graham Management isn't sending our funds to us. We received no money this month from Graham Management for homeowners' LFCA membership dues. Jodi C. will contact Graham about our payments.

We provided food for about 220 people and it all went. This board agreed that a pool party event should be held again next year. We need to send a \$400 invoice to the Fund for their portion of the event budget. Scott J. made a motion to pay the DJ \$75. Lori E. seconded the motion and it passed unanimously.

Jodi C. must wait another week to contact Precinct 3 Parks Department about booking the local park pavilion. A tentative date for the event is September 30, with a backup date of October 7.

#### **Bylaws Update**

Jodi C. will send out the draft to the board members for review and then send it to an attorney. We previously approved up to \$500 for the attorney fee. The goal is to vote on and approve the changes at our annual meeting in October.

#### **School Clothing Swap**

Jamie M. put out a save-the-date notice for August 6 at the pavilion at Russ Poppe Park. The event will run from 9 AM to noon. We will ask the Fund to send out an email blast.
