## Human Trafficking

The exploitation of vulnerability

The trade of human beings through force, fraud, or coercion for the purpose of exploitation for labor, sexual purposes, or organs.

"Trafficking in Persons is the face of modern day slavery"
-U.S. Department of State



# Human Trafficking: Experts Report

- In 2016 at any given point, there were 40.6 million people enslaved worldwide.
- 2nd largest, fastest growing criminal industry in the world.
- More slaves today than during any other time during recorded history, including the trans-Atlantic slave trade.
- Human Trafficking cases have been reported in every state in the USA including Virginia.\*

## Human Trafficking

#### According to U.S. law:

Any minor (anyone under the age of 18) who is induced to perform a commercial sex act is a victim of human trafficking, regardless of whether there is force, fraud, or coercion.





# Common Forms of Human Trafficking

- Familial Trafficking
- •Survival Trafficking
- Pimp Control
- •Gang Control



#### Who are the traffickers?

- Both females and males have been convicted for their involvement as traffickers
- "Boyfriend/lover boy method", girl friends of pimps, family, gangs...
- Traffickers: anyone helping in the entire process of trafficking: recruitment, transportation, harboring, exploitation



#### Who are the victims?

- Trafficked persons in the U.S. can be men or women, adults or children, foreign nationals or US citizens. Some are well-educated, while others have no formal education.
- Average age of entry: 11-14
   for boys and girls
   (U.S. Department of Justice).
- 74% of trafficking victims were trafficked between childhood and age 23 (Polaris, 2016).



#### Common Victimization Risk Factors

- Dysfunctional family situation
- Low self-esteem
- Lack of monitoring, adult supervision, or caring adult in the student's life
- Childhood sexual abuse
- LGBTQ youths are at greater risk
- Mental illness, learning disabilities, developmental delay
- Substance abuse
- Uncertain legal status/loose paperwork; language barrier



#### Who are the victims?

Common examples of identified child trafficking industries include:

- Commercial sex
- Stripping
- Pornography
- Forced begging
- Magazine crews

- Au pairs or nannies
- Restaurant work
- Hair and nail salons
- Agricultural work



## Myths

- Human trafficking only occurs in illegal underground industries
- Trafficked persons can only be foreign nationals or are only immigrants from other countries
- It's a crime that must involve some form of travel, transportation, or movement across state or national borders
- It doesn't happen here

#### Myths

#### Recruitment

- Social media/online/apps, shopping malls, parties, neighborhoods, homes, bus stops, after-school programs, clubs, group homes, and even in schools. Abduction.
- Some traffickers use students to lure and **groom** their own peers.
- Common theme: False Promises; Preying on vulnerability







# Reality - The Signs

#### Social:

- Disoriented or confused?
- Showing signs of mental abuse?
- Is the person fearful, timid, or submissive?

#### Physical:

- Signs of physical abuse (ex. bruises in various stages of healing)?
- Signs of being denied food, water, sleep, or medical care?
- Being kept in a van or trailer, unable to leave?

#### **Conversational:**

- Is the person often in the company of someone to whom he or she defers? Or someone who seems to be in control of the situation, e.g., where they go or who they talk to?
- Does the person appear to be coached on what to say?
- Does the person have freedom of movement? Can the person freely leave where they live?

The 2 or 6 lesson academic curriculum is delivered to middle/high school students in their classrooms.

We believe that in order to prevent teen human trafficking before it happens, we must educate our teens, so that they will not become victims of this crime affecting their generation and instead become informed and responsible world citizens.


