

These drivers, and many more impact the system of care





System Drivers

- National policies and Federal Oversight (Families First Prevention Services Act, Kinship Licensure, Child and Family Services Review)
- Federal Class Action Lawsuit (Remedial orders, court monitors, more regulation, more oversight, risk aversion)
- Changes and impact from the pandemic (workforce challenges, higher costs)
- Priorities of the Texas Legislature and Executive leadership (Community Based Care, reducing entries into foster care, reducing children in unregulated care aka "CWOP", permanency, Texas Child Centered Care "T3C" aka: rate modernization)



What is "the lawsuit"?

Filed in 2011 (sec. 1983 case—caseloads, lack of placement array, problems with group homes)

Special Masters made recommendations and then issued their own Implementation Plan in December 2017—which largely formed the basis for Court's final order in January 2018

Trial December 2014; Memorandum Opinion by district court December 2015—injunction to develop policies, aided by appointed Special Masters Various appellate activities until mandate issued and remedial orders took effect July 2019

Remedial Orders

- 46 specific orders upheld by 5th Circuit or not appealed following issuance
- District court has shown inclination to read orders broadly; one unfavorable ruling from 5th Circuit on this
- Some narrowly drawn such as timelines for investigation closure. Others much broader:

DFPS shall ensure that reported allegations of child abuse and neglect involving children in the PMC class are investigated; commenced and completed on time consistent with the Court's Order; and conducted taking into account at all times the child's safety needs. The Monitors shall periodically review the statewide system for appropriately receiving, screening, and investigating reports of abuse and neglect involving children in the PMC class to ensure the investigations of all reports are commenced and completed on time consistent with this Order and conducted taking into account at all times the child's safety needs

Since the stay was lifted

- Regular status hearings + relatively frequent emergency hearings
- 2 monitoring teams, each with various staff.
 Texas has spent \$180 million fighting against, losing and complying with foster care suit (dallasnews.com)
- State currently appealing contempt order for subset of investigations related to class
- Lawsuit commands intense focus from media, nonpractitioner stakeholders, and public. Drives decisions of direct impact to providers—e.g. Heightened Monitoring...

Heightened Monitoring


- Modeled after an improvement (and provider closure) tool utilized in Oklahoma
 with some significant differences
- Implementation began in 2020
- Brass tacks of methodology—initially opaque
- Monitoring teams—visits can be extensive
- Relatively low number of successful exits;
 some providers remain on 4+ years later

Practical Implications... What does this all mean in real life?

Closures and contract terminations


- 131 operations closed because the operation relinquished its license or because HHSC revoked the license
 - 125 operations voluntarily relinquished their licenses to HHSC, 6 had licenses revoked by HHSC
- 370 operations that had their contracts terminated by DFPS and SSCCs
- Factors impacting capacity loss:
 - Heightened monitoring
 - Increased risk for staff and orgs with investigations
 - Focus on keeping kids in least restrictive settings
 - Increased resource needs: cost of living, workforce, additional compliance needs, implementing new treatment models

Foster home capacity has declined by 9,000 beds since 2019.




The amount of abuse and neglect provider investigations (DFPS) are down, but still higher than 2019.

Number of closed CPS Residential Investigations




The number of validated licensing provider investigations (HHSC) appears to be back at 2019 numbers.
