MINIMUM QUALIFICATION STANDARDS FOR THE SLATE: Candidates for Director Positions shall have been actively engaged as a REALTOR® member of the Board for at least two years. Candidates for Officer positions must have previously served as a Director.

All candidates must be in good standing. All candidates must be willing to sign the Code of Conduct and support the Board's advocacy and program of work.

All submissions should be typed.
