AN ORDINANCE AMENDING ORDINANCE NO. 2006-4 ENTITLED "AN ORDINANCE REGULATING THE SALE OF ALCOHOLIC LIQUOURS FOR THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS"

BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois, as follows:

Section 1: Ordinance No. 2013-11, is amended by deleting sub-paragraph (3) of paragraph (a) of Section 15 (Class "C" license) in its entirety and replacing it with the following new paragraph sub-paragraph (3) of paragraph (a) of Section 15 (Class "C" license):

- (3) A Class "C" license shall permit the sale of beer for consumption on or off the licensed premises, and the fee for such license shall be One Thousand One Hundred Dollars (\$1,100.00). A Class "C" license shall permit sales as follows:
 - a. For consumption on the licensed premises:
 - 1. From 6:00 a.m. on each Monday through Thursday until 10:00 p.m.
 - 2. From 6:00 a.m. on each Friday and Saturday until 10:00 p.m.
 - b. For consumption off the licensed premises:
 - 1. From 6:00 a.m. on each Monday through Thursday until 1:30 a.m. on the following day.
 - 2. From 6:00 a.m. on each Friday and Saturday until 2:00 a.m. on the following day.
 - 3. From 12:00 noon on each Sunday until 1:00 a.m. on the following day.

Section 2: This ordinance shall be in full force and effect upon its passage and approval as provided by law.
