- The planned CMSA sanitary sewer line main extension for Jones Street and Mountain Road from July 2010.
- The plan for gravity fed sanitary sewer service and the approximate cost associated with the line development and or grinder pump.
- Easements will be required no matter what option is decided upon.
- Mandatory sewer tap-in for properties within 150 feet of the sewer main.
- CMSA board and engineer are researching the most feasible method to tap into the sanitary sewer main.

- Engineer to apply for a small sewage grant from PA Small Water and Sewer, for sanitary sewer line extension for Mountain and Jones Street.

## Engineers Report: Plant Operators Report:

- PA Small Water and Sewer guidelines, The Commonwealth Financing Authority is accepting applications for water and sewer projects with a cost of not less than \$30,000.00 and no more than \$50,000.00. There is a matching fund requirement, 15% of the total eligible project cost. A \$100.00 non-refundable application fee. Applications will be accepted between August 1<sup>st</sup> and October 31<sup>st</sup>, 2016.
- Belt press was operated and adjusted by Jim and Ron for more efficiency when pressing sludge, due to the fact; the new spray nozzles were installed.
- Monthly eDMRs were completed and submitted to the DEP by Jim, Ron and Brian.

- Ron and Jim have done a visual inspection of the sewer main right-of-ways, throughout the sanitary system. Some trees have grown past the use of a weed trimmer.
