#### WAIVER AND RELEASE FORM

I hereby waive, release and discharge for myself, my heirs, legal representatives, and successors in interest (hereinafter collectively “successors”) any and all rights and claims which I have or which may hereafter accrue to me against the administrators of this event, the Hollister Police Department Explorer Program, Hollister Police Department, City of Hollister sponsors and its personnel, and all other persons or entities, including, without limitations, any claims for injury, including death, and for any damage to property arising out of or in any way related to the Hollister Police Explorers 5k Foot Pursuit or my participation in the Hollister Police Explorer 5k Foot Pursuit.

I agree for myself and successors that the above representations are contractually binding and are not mere recitals and that should I or my successors assert my claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the other part or parties. This agreement may not be construed as modification of any of the provisions herein or consent to any subsequent waiver or modification.
