## Tournament Eligibility Requirements

Hosted by Kingpin's Alley

This tournament is certified by the United States Bowling Congress and any USBC rule not specifically stated, waived or modified in these rules will apply where applicable. Download this form at www.adkusbc.com.

1. Competition - Lanes will be stripped and oiled before every squad

Competition will consist of five-player Teams, Doubles, Singles and a nine-game All-Events (total of team, doubles and singles scores) in TWO HANDICAP DIVISIONS for each event as follows:
TEAM - Division 1-1051 \& over (1150-plus bowls scratch); Division 2 - 1050 \& under.
DOUBLES - Division 1 - 421 \& over (460-plus bowls scratch); Division $2-420$ \& under.
SINGLES - Division 1-211 \& over (230-plus bowls scratch); Division $2-210$ \& under.
ALL-EVENTS - Division 1 - 211 \& over; Division $2-210$ \& under.

- Bowler's first appearance in each event counts toward All-Events. Bowler must pay All-Events fee before rolling first ball in the tournament to be eligible for All-Events.
- Split entries for double and singles will be accepted. Bowlers will be allowed to enter just doubles or just singles (based on lane availability. The ADK USBC is not responsible for obtaining doubles and singles partners for any entries. All doubles/singles will be bowled on the same pair of lanes.
- WALK-INS WILL BE ALLOWED IF LANES ARE AVAILABLE. PLEASE CALL AHEAD 518-793-9606
- Lanes will be assigned by the tournament director. Please note that there may be up to 6 bowlers per pair on all doubles/singles squads.
- On squads where brackets are offered, the maximum number of brackets per person in each category (handicap or scratch) is 50 . Brackets will be conducted during Team competition and during both Doubles and Singles competition. BOWLERS WITH AVERAGES OF 220 OR HIGHER CAN COMPETE IN SCRATCH BRACKETS ONLY.

2. Entrants-The ADK USBC Open Championships are open to all members in good standing of the ADK USBC association and are conducted under USBC rules and regulations. No USBC memberships will be sold at the tournament site through the tournament.
3. Multiple Participation-Multiple participation will be allowed. In order to place more than once in the prize list for position standings: Team event - at least two players in the lineup must be different. Doubles - at least one player in the lineup must be different. Please note that in the Singles event, the same individual can not place more than once.

## 4. Averages

a. Entrants shall use their HIGHEST USBC certified league average, as a regular or substitute bowler, in the following order:

1. Official average for the past winter seasons (2022-2023) for 21 games or more, or past summer season (2022-2023) for 21 games or more, unless the 2023-24 average is 10 pins or more higher for 21 games as of January 1, 2024. THUS, RULE 319A-2 WILL APPLY. Average verification in writing is required.
2. As of January 1 for the current season - 21 games or more - substantiated with a league standings sheet;
3. All others bowl scratch. - PLEASE NOTE THAT USBC RULE 319A-3 WILL APPLY.
b. Sport League averages must be submitted on the entry form and noted as Sport.
c. Any averages not available at Bowl.com must have a league standing sheet or signed verification by the local association manager.
d. Re-rating will apply; Bowlers must report re-rates and refusal of any re-rates, and indicate whether submitted averages are from a Modified or Challenge League. The tournament director has the right to adjust any average.
4. Handicap

Handicap will be determined using a TEAM HANDICAP METHOD, and will be based on 90 percent of the difference in the cumulative averages and 1150 in the Team Division 1 event, 460 in the Doubles Division 1 event and 230 in the Singles Division 1 event, OR 90 percent of the difference in the Cumulative averages and 1050 in the Team Division 2 event, 420 in the Doubles Division 2 event and 210 in the Singles Division 2 event. Teams, doubles and singles entrants over the divisional limits will bowl scratch.
6. Entry Fees
-Entry fees are $\$ 30$ per event per person ( $\$ 10$ for optional all-events) and must be paid in full prior to competition.
-Team event: $\$ 150$. Doubles: $\$ 60$. Singles: $\$ 30$. All-Events: $\$ 10$ (must be paid before bowling in the first event). Prize money will be awarded $100 \%$ with ratio of 1 in 8 .
7. Association Champions

Awards (plaques, trophies) will be presented to the Handicap champions of the four events. Bowlers with the highest scores will be declared the ASSOCIATION CHAMPIONS in each event. Only bowlers who have paid the All-Events fees will receive monetary awards in All-Events.
8. Disclosure

Entrants whose names appear here or their authorized replacements hereby agree that the ADK USBC Inc., its officers and agents shall be liable only to the extent of returning the prize portion and bowling fees of an entry if and when these entrants shall be prevented from bowling any event in the tournament through premature termination of the tournament, which may be brought about by war, national emergency or emergences from fires, strikes, lockouts, labor difficulties or other causes beyond the control of the ADK USBC.
