If you request an after hour pick up or drop off where a check in sheet is completed to release responsibility, a rental representative will have to be present, this service will need to be pre arranged, and is available at our discretion based on personnel availability for a fee of \$150.00 for this service. If you choose to drop the unit at our location after hours without a rental representative present, you accept full responsibility for the unit until the next scheduled regular business hours, and if you are not present at the time of check in inspection, you agree to any fees indicated by the check in inspection.

Towing Policy: If you plan to tow anything behind the RV, you must disclose this intention prior to pick up and the tow vehicle weight must be within the towing capacity of the RV. Any safety equipment required by law to tow your vehicle is the sole responsibility of the renter. **The trailer you are towing must have its own liability insurance policy and a copy of the insurance card must be provided.** Your initials on this policy states that you understand and agree to this policy.
