

Dogs At Large

A dog-at-large is a dog running loose, a dog on leash on another person's property, a dog off leash more than 10 feet from the owner or off leash on another person's property. All of these are in violation of the ordinance and subject to fines. Dogs are to be confined to the owner's property. If a dog is on leash it is unlawful for the dog to be on another person's property. If the dog is off leash it must be within 10 feet of the owner and under voice command and again it is unlawful for the dog to enter other people's property. If a dog is chasing wildlife, the owner is subject to fines by Teller County and the Division of Wildlife. In addition the dog can be destroyed for chasing wildlife or livestock.

Colorado Life Trak

The Teller County Sheriff's Office has brought Colorado Life Trak – <u>at no cost to participants</u> – to assist its residents who have medical conditions that may cause them to wander. The project is a rapid-response partnership with law enforcement aiding victims and families suffering from Alzheimer's Disease and related disorders and conditions such as Down Syndrome and Autism. Reminder From Valley Maintenance Corporation (VMC)

VMC wells are permitted by the State of Colorado for use of water only within the house. This excludes use of water for anything outside the house including washing cars, lawn or garden watering, livestock watering, etc. If you would like to use water outside the house you can purchase a water tank and water from locally owned water delivery companies. Please review the water regulations you received from VMC for further clarification.

If you have your own well and would like more information on your well permit, those details can be found on the well permit website at <u>www.dwr.state.co.us/wellpermitsearch</u>.

It is also a violation of Colorado law to capture and retain rain water. Colorado Water Law requires that precipitation fall to the ground, run off and into the river of the watershed where it fell. Because rights to water are legally allocated in this state, an individual may not capture and use water to which he/she does not have a right.
