- I. Official quorum was reached by those present and proxies received prior to the meeting. Board has the formal list of attendees and proxies.
- II. Deeding of the Lake
 - Jeff reviewed when the deeding took place: Oct. 2014
 - Jeff communicated that the LOA owns the lake.
- III. Budget/Expenses for 2016 were reviewed
 - a. Income-Assessment of fees
 - i. Jeff reviewed assessment via the bylaws and opportunity to change via a vote moving forward.
 - ii. Initial assessment was approved
 - b. Estimated Expenses
 - i. Insurance for Liability is needed
 - 1. Recommended that we receive at least 3 estimates for comparison.
 - ii. Real estate taxes may get reimbursed for the amount Dave Price paid as payment was previously sent.
 - iii. Frank had an updated amount for Pond Treatment (\$304)
 - iv. Pond Maintenance Additional treatment for this year was recommended by contractor but most likely will not take a full treatment. Analysis will be performed in the spring but ½ of last year's cost is estimated for new charges in FY16.
 - v. Beaver Investigation No invoice has been received yet.
 - 1. Muskrat was identified
 - 2. No proof of beavers in the lake currently.
- IV. Election of Existing/New Board Members Dave Price posed a question about people being on both boards and that this may be a conflict of interest – It was decided that if conflicts arise, folks on both boards would abstain from voting.
 - a. Frank Armetta, David Meyers and Mike Livermore volunteered for at-large positions on the board.
 - b. Greg, Jeff, Troy (existing board) and Frank, David, and Mike (new at-large positions) were approved as the FY16 Board of Directors.
- V. Other issues concerning the LOA
 - a. Question was asked as to whether the HOA would cover some of the costs. No decision, but we need to get the LOA organized before discussions resume.
 - b. Checkbook/Bank Account needs to be set up.
 - c. PO Box needs to be set up for remittances, etc.
 - d. Need Fy16 assessment to go out ASAP
 - e. Future Pond Ideas/Upkeep Additional ideas for future pond maintenance Board will investigate costs associated with the proposed items below:

- 1. Aeration
- 2. Sterile Grass Carp Initial estimate of \$600/Carp and need 2 or 3. Need additional work to make sure they don't escape.
- 3. Fountains
- 4. Potential Dredging needs
- 5. Edging around lake
- 6. Clean up silt in and trees
- 7. Inspection of storm drains Potential Village issue
- 8. Potential of Restocking Fish and revising the Catch and Release item in bylaws
