# **Guidelines for Peace Project Proposals**

### Proposals will be reviewed for the following types of projects:

International Professional Exchange Program (PEP)

participants representing equally conflicting countries/groups.
 Conference participation grants with equal

representation from conflicting countries/groups, with the condition to jointly conduct a workshop on the conflict situation experience.

• Any other project in collaboration with other organizations involved in peace and conflict resolution issues, sharing the same philosophy as CIF.

### **Review Process**

Proposals are presented to the Executive Committee (EC) Secretary to be put on the next Board of Directors (BD) agenda. The BD will discuss and decide on the project. If approved by the BD, it will be included in the budget line allocated for Peace Projects. Donations earmarked for Peace Projects will clearly appear in the annual financial statement. (*Approved in Sweden*, *BD 2015*) Five (5) euros per person are added in the conference fees beginning from 2019, to be included in Peace Project Funds. (*Approved in Utrecht Holland DB 2016*)

It is possible that the Peace Project grant is sent in advance or after the project is finished, according to the proposal. The final report should consist of general and financial parts (how the money was spent).

### The general part should consist of:

- Objective of the project
- Activities
- Outcome
- Results, what went well what did not

### The financial part should consist of:

- How much money they received and what was spent
- The expenses should be accompanied by bills and
- receipts for review by the treasurer
- Operational result

### room: € 295, in a double room it is € 245.


**Extra nights** (including breakfast) can be booked – see application form.

### Austrian social work students assist in the preparation and implementation of PEP



Again this year CIF Austria organized their annual PEP (Professional Exchange Program) in cooperation with the University of Applied Sciences. Three students under the supervision of **Doris Stephan** (CIF Austria) wrote the following article about their experiences with the current PEP for the World News.

At the beginning of the semester, we, a mixed group of social work students in our final semester at the University of Applied Sciences in Vienna, sat together for the first hour of the optional CIF course. Many of us had never heard of the organisation up until that point. All we had to go on was a tantalising course description: "direct and intensive exchange with social workers from different countries and from different fields." Beyond that, we had little idea what was in store for us. We were given a timetable and asked to plan for an eighteendayseries of events and talks.

It was with an air of openness and curiosity that we began planning a series of activities and events to help our (as yet unknown) guests become acclimatised to the Viennese social system. The course was centred on By – David Titcumb , Veronika Witzani and Fabio Menches – social work students from the University of Applied Sciences in Vienna, Austria

four specific events: a city tour, a welcoming party, a main public event in which the participants presented their individual countries and working conditions, and a reflection round in which everyone had the chance to discuss all aspects of the two week visit. Each of these was taken over by a small task-group whose responsibility it was to plan their event – there was room for innovation but, in practice, the program was quite tightly regulated.

We met the participants for the first time on a sunny Tuesday morning in April. Immediately they greeted us with open arms, answering questions, being inquisitive about our studies. They came from a wide variety of fields: child protection, healthcare, probation services and youth welfare, among others. They also represented a wide range of ages and demographics. It did not take long for them to start asking questions about the things

we had been studying. It was striking how interested they all seemed to be in our studies and our lives – much more, in fact, than in the fabulous baroque buildings around us.

Apart from the obligatory walk around Vienna's beautiful historic centre, we had the chance to visit many of the Viennese social welfare institutions with the participants. The city is rightly proud of its social system. There are provisions for many groups of marginalised people, provided by both state and nongovernmental organisations. In the course of the project, we were able to take a closer look at these institutions and experience them through the



eyes of professionals, taking note of the questions they were asking and experiencing how they compared their own systems with those they were seeing in Austria for the first time.

The best part, of course, was meeting the participants and sharing with them some of their more valuable experiences in the field. It is impossible to quantify how much can be learned from this kind of exchange; the personal questions you feel empowered to ask as the night wears on and you get to know each other a little more are the most revealing. I found it fascinating to hear how the participants coped with their workload and why they were motivated to work in their chosen fields. I also enjoyed learning about the customs and cultures in all of the different countries. It was a fascinating journey to many different corners of the world, and we quickly created strong bonds with one another.

"I can't tell you how interesting it has been talking to the students here – it's really amazing to see what social workers of the future are being taught," said Pantelis, a Greek youth probation worker, who himself often hosts interns in his department at home. Having such deep conversations about the state of the European Union, about identities and nationalities was enriching. We felt challenged to consider our role as social workers on an institutional and political level, in an international context, as the borders between our countries seemed to shrink before our eyes.

Towards the end of the stay, the participants hosted a so-called 'World Café' in which they presented some facts about their countries, their jobs, and also the social and political context in which they work. There was representation from the 'richer' north as well as the south of Europe, which has been blighted by austerity, in addition to less economically developed countries such as the Philippines and Nepal which enjoy much less state provision of welfare. All of the social workers demonstrated the passion and dedication they have for their respective causes – this was truly inspiring.

The last event invited us all to reflect on the visit and we were able to put into perspective what we had all learned.During the course of our studies, we students have been confronted with the destructive aspects of

human nature.Most of us came of age during the financial crisis, the late effectswhich have dramatically altered social work practice. We have also seen firsthand the results of the populist backlash following mass immigration into Europe in 2015, including all of the vitriol and political opportunism that accompanied it. Over the last three years in particular, we have endured an era of tumult and turmoil. This drip-feed of

negativity highlights the complexities of working with some of society's most vulnerable people.

However, being around these eight inspiring professionals allowed us to reflect on our position in Austria. Talking to the participants was inspiring, but seeing them in action and hearing about their projects helped to remind us why we wanted to become social workers in the first place. The experience was invigorating and I was particularly inspired by the tenacity, energy and creativity of every single one of the members. The best part was that this was reciprocal. "It's you, the students, which have made this trip such a brilliant success," said Pantelis again. "You have inspired us all, and I really mean that. Without you, the CIF experience would not have been half as good."



# **European Project ReSport Continues**

CIF FRANCE continues work on the Erasmus + project with European partners. The fourth meeting was held in Ankara from 16 to 18 May 2018. The experts and partners (Croatia, Hungary, Northern Ireland, Slovenia, Portugal, Turkey, Italy and CIF France) met to continue action on the reintegration through sport for people with disabilities.

# Austrian participant describes her experience in Mumbai

Here is the gist of my observations during the CIF Mumbai India Exchange Program. I found the opportunity to learn new dimensions of social work there and had a great time with the CIF Mumbai group of social workers, some of the last participants of PEP Austria, two lovely host families, their relatives and common friends.

Wehad a tight schedule. The first three days gave detailed insight into the organisational structures of the Tata Institute of Social Sciences (TISS) – a multi campus public-funded research university creating human service professionals. It was established in 1936 asthe first university of social work in India. It offers innumerable possibilities of research in the field of social work plus planning and implementation of projects. Notable initiatives I got to learn about are Koshish (social work in criminal justice), Jiyo Parsi (work with Parsi community), etc.

Several field visits gave insight into thehard facts ofsocial and community work specially with women,children,slums, homes for high-risk women and children,crime and prostitution, domestic violence, work in government hospitals fortaking care of basic financial needs of the patients and psycho-social care of their families,fund raisingto compensate the meager welfare system, emergency services, networking with state agencies and non-governmental organisations(NGOs) for intervention, advocacy and resource mobilization.

### Here are some of the highlights:

 Social work in government hospital: Multiprofessional teams withservice offers (as seen on the photo attached) cooperate to take care of the patients. One big resource for social workers is the readiness of business people and companies to give financial

support to poor patients (bearing costs of operation, rehabilitation, emergency help, etc.)It seems that the business sector in Mumbai has always been ready to give money for charity. In addition, an India-wide change took place in company law in April 2014, the so called "2 percent law", according to which at least 2 percent of profits are to be spent for charity.

2) Micro-business enterprises: Numerous self-help groups, created and initiated after having surveyed the needs in different parts of Mumbai and Maharastrawith the help of bank credits, like Vermiculture manure (compost produced and sold); delivery of home cooked food to offices;domains of handicrafts;tailoring, etc. During a three day rural camp in the small town Mahabaleshwar, it was impressive to see the manifold management of an extensive strawberry culture, funded by micro bank credits.

 Visit to a diamond factory: under the supervision of social workers.

4) Intensive cooperation with various NGOs involved in

slums: for women and child development, handicapped people, homes for high risk groups, work with socio-economically vulnerable communities and individuals who are at greater risk of being criminalized or exposed to trafficking for the purpose of sexual exploitation, etc.

5) Mumbai-sightseeing: A restaurant with unique concept and great food where the serving staff is hearing- and speech-impaired (the menu card has hand signs to order food, thus offering a crash course in sign language); Dhobi Ghat, the world's largest outdoor laundry; visit to a naturopathy health center.

6) Creative Handicrafts: A boutique (a private initiative) with three chain stores and a catering service in Mumbai. Women from surrounding slums are selected by social workers, are given

tailoring training and employed there under very good terms. Less talented women in the tailoring branch work in the catering and deliver homemade food to offices.

# Israeli shares experience with host living in Baltic PEP

n May and June of 2016, I spent three weeks in Estonia and Latvia, and participated in the PEP in each country. I will concentrate here only on the aspect of personal hospitality that I experienced, and not on the professional aspect, of which I've written before. I'll just say that all in all the whole experience was exceptional and unforgettable in all ways, and I cherish the many wonderful memories from the time I spent in those countries.

In Estonia, I spent 10.5 days in Tallinn, and after the first three nights at the apartment that CIF rented for the four of us together during the orientation, I spent eight days and nights with a local young couple, who lived in a charming private house with a large yard, with a dog, in a neighborhood of Tallinn. The hostess, Anni de Forest, an active member of CIF Estonia, is a social worker who worked at the time in a large hospital in the city. Her partner is not directly involved with CIF but supported her and helped during my stay. I was immediately made to feel very welcome in their home, was given a private room and encouraged to take anything from the refrigerator and kitchen.

Anni and her partner left early for work, but I managed very well by myself with the breakfast and had plenty of things to choose from. I ate the main meal with them later in the day, or some days were taken out to dine with other CIF members. Anni was very friendly and made efforts to help me acclimate, showed me around the neighborhood with all the bus stops and train station I needed, explained how to walk, and told me about their surroundings. On Saturday, a day off, she took me with another CIF participant to her home town of

### Haapsalu, including to her parents' home, and gave us a wonderful tour of the interesting and historic town. Anni also hosted us at her workplace and showed us departments of the hospital and the social service where she worked. She and her partner also helped me with rides home from the city at certain times and always tried to be of help in many ways. One day after our program she

always tried to be of help in many ways.One day after our program she took me (with the other participant) to her dog's sport class which was a lot of fun, and then we walked along the beach, and enjoyed a nice evening with her.

Anni and her partner, Artur, hosted the farewell event for the other PEP participant in Tallinn and myself on the last evening at their yard, and made it a lovely and heartwarming event, when most of the

CIF locals attended. The other two CIF participants were staying in other towns so did not attend. It was hard to say goodbye to them! I am still in touch with Anni, who sends me greetings for occasions like New Years and my birthday!

In Latvia I spent eight days with a hostess in Riga and two nights and days with another hostess in Liepaja, a town on the West Coast.In Riga I stayed with Zena, a lovely lady (former social worker and active CIF member) who also made me very welcome and comfortable in her cozy apartment. I had a private and spacious room to myself. Zena also gave me an informative tour of her neighborhood, showed me all the important transportation landmarks and taught me how to navigate in Riga. She bought different delicacies and spoiled me with delicious local foods and treats, making sure I tried everything! Since Zena also left early for work, I managed well myself, took my breakfast alone, and enjoyed delicious main meals with her at the end of the day. Zena showed a keen interest in me and my activities. She also accompanied me (with another participant) to some of the professional visits. She is very interesting to talk to and made very good company. I felt very welcome and comfortable with her and enjoyed her company all through my stay, and was sorry to leave!

In the town of Liepaja I spent two days and nights with Vinita, a social worker who worked with

handicapped people and also taught social work at the University. Vinita gave me a private studio apartment right next to her own, with my own bath, and comfortable facilities. 

# Social worker from Athens experienced a professional and enjoyable CIF program in Spain

The CIF program organized by Spanish colleagues was the first in terms of reception of social workers, while Spain actively participates in the mission of colleagues in other CIF member countries.

The program included four social workers (Greece, Germany, Costa Rica and Argentina). The first phase was grouped where all the participants shared the same activities and the second phase was individual where each participant followed an individual schedule.



During the program in Madrid, I had the chance to visit the community social services, be informed about the public network of social care for people with mental disease and understand how the Council and the Associations of Social Workers act in Spain.

On 16-5-2018 I traveled to León, a town in the northern part of Spain where my individual program started. I visited

structures to protect immigrants and refugees, social services, the private School of Social Work in León, older people's accommodation structures, and hospitality structures for persons with mental illnesses. I also had the opportunity to take part in the General Assembly of the Association of Social Workers in León. At the meeting I had the honor to



present the work of the social workers in Greece.

Making an assessment of my participation in the program, the feeling that is prevalent is a positive one and satisfaction of my expectations. The daily program was demanding, complete, full of new knowledge.

The contact with the social services has enabled us to get to know the welfare system, its structure, the benefits, and the role of the social workers in it. We found differences and similarities in the way we practice, not only in Spain but also in the countries where the other participants came from.

Beyond the benefits at a professional, educational level, the bonding created between the participants in the program was something unexpectedly enjoyable. The Spanish colleagues, always willing to learn from us and not to teach us, have been loyal and supportive throughout the program. The program was experiential, alive and characterized by interaction, respect for the work and personality of each other and fellowship.

In closing, I have to admit that I am happy on my personal level, because my self-confidence has improved. I have improved my knowledge of Social Work Science and Practice, successfully applied my knowledge of the Spanish language and acquired new friends.

We would like to share some information and moments from the 13<sup>th</sup> CIF Hellas International Professional Exchange Program, which took place in Athens from 07-19 May 2018 with four professional social workers:

1. Andria Cubero from Arizona, USA working at Area Agency on Aging - Mosaic Refugee Program (MERP); 2. Ceylan-Pinar Karatas from Turkey working at Istanbul Provincial Management Department of Adoption; 3. Maria Johanna Manninen from Finland In charge of housing for children without parents who have arrived to Finland as asylum seekers; and 4. Taylor Daniel from Michigan, USA social work/psychotherapist working at North Country Community Mental Health, in Petoskey, Michigan.

The program included:

•Orientation Seminar to get together participants and organizers

•Lectures to familiarize participants with the socio/economic situation in Greece

•Agency visits as group to organizations for refugees, juvenile offenders, abused women, child protection and mental health **Placement to agencies** dealing mainly with refugees, child protection issues and elderly

•Cultural activities and cross-cultural exchange work methods and intervention practices amongst themselves as participants came from different countries

Host-family living provided them with a unique cultural experience and develops lasting cross-cultural friendships The last Day participants shared gained knowledge and experience during the evaluation process and received their certificates during the farewell party.

CIF Hellas would like to thank the Hellenic Social Workers Association, the governmental and non-governmental organizations, the host families, the speakers, the president of the National Center for Social Solidarity (EKKA), CIF Hellas members and friends who helped to organize and implement the CIF Hellas IPEP 2018.

# **Cyprus Organizes an International Exchange Week**

February 5th – 9th 2018, the European University Cyprus, the University College Leuven-Limburg, and Windesheim University of Applied Sciences organised an international week for social work and youth studies students that took place in Zwolle, in the Netherlands.

Students from the three universities accompanied by a lecturer contributed by preparing a presentation about their respective countries, and two presentations about how specific case studies (one describing child sexual abuse and one describing neglect that were made available in advance) would be dealt with



in their countries. In order to prepare the cases the students had to familiarise themselves with the law, guidelines, available services, etc. in their countries of origin.

The International Exchange Programme included lectures and case studies, teamwork, field visits, and cultural (e.g. international buffet) and social activities. The main goal for this International Exchange Programme 2018 in Zwolle was to allow students to interact with students of other nationalities and give them an opportunity to share their experiences as students in the fields of social sciences.

Additionally, all students worked on designing a prevention project for a special target group: offenders, parents, professionals (social workers, pedag., teachers), teenagers, etc. In small groups, they were asked to design a European project that could be implemented in

The Cypriot students received an award by the Rotary Club in Nicosia that contributed towards their expenses.
