### **Post Office Security**

A recent news release stated that a company named Sharper Image, the maker of high-tech toys for grown-ups, is selling a \$39 aerosol spray that turns a thick manila envelope transparent, allowing the user to read what's inside.

"The X-Ray Spray, which has been on the market for two weeks and could replace the tea kettle method of steaming open envelopes, begins to evaporate within 30 seconds and leaves no indication that the letter has been altered.

"Several applications at \$3 per ounce might be needed in order for the contents of an envelope to be readable, the San Francisco-based maker said.

"The can's label carries a warning that tampering with or opening the U.S. mail is a crime carrying a penalty of up to five years in prison or a \$2,000 fine, or both.

"The company claims in its promotion campaign that the spray allows the user to 'protect your personal and business interests' and that the substance is used by U.S. government agencies.

"...A postal inspector with the U.S. Postal Service in Washington, was less enthusiastic about the spray. 'How can you call it a practical joke when it applies to prying into someone else's business? And I don't know what government agencies they're talking about, because we certainly don't use it.'" End of quote.

The news article didn't say if the postal inspector was new and just recently hired off the streets or if he had his tongue in his cheek when he spoke!

There are companies whose sole business is to provide the most complete and up-to-date hardware for all types of surveillance, investigative aids and eavesdropping. These companies sell telephone tapping equipment, bionic ears and laser beam listening devices. They sell the very chemical compound discussed in the article. They sell very small borescopes that allow a person to view the contents of an envelope by simply inserting the very small probe into the envelope at a corner.

No, with court orders, the government can do anything. Some federal agencies don't even bother with court orders.

Several years ago the HBO movie system produced an outstanding video documentary that showed some of these devices in action. It very honestly showed the excesses of government and the misuse of the law. The documentary was simply titled *"Surveillance"*.

### **Terrorism**

The use of the word "terrorism" is totally misused and over-used in our modern American news media and government circles. Any act of war is "terror" in the total meaning of the word. When acts of what is called "terrorism" take place, it can be considered an act of war. The terrorists in these instances of car bombings and pipe bombings, etc., are simply guerrilla soldiers who are inflicting casualties on the civilian population. When a government chooses to attack a civilian population on a massive scale, such as saturation bombing of nonmilitary targets, that strikes terror is the hearts of those civilians.

It appears to be a national policy not to permit the American people to know too much about acts of guerrilla warfare when they occur but it is becoming increasingly more apparent that attacks are occurring in many parts of the country. In a past issue it was reported that three different high voltage power lines emanating from the Palo Verde nuclear power plant near Phoenix, Arizona had been deliberately damaged simultaneously by unknown persons.

There have been many different incidents at oil refineries that were summarily classified as accidents by the news media with statements to the effect that the "investigation of the cause was continuing." Off-shore oil drilling platforms apparently have been heavy targets for these "accidents."

The U.S. Energy Department has finally advised U.S. companies of a growing threat of attacks on vital domestic energy facilities and is encouraging, even pressuring, them to fortify their property.

The National Security Council has created a special inter-agency task force to assess the vulnerability of the nation's energy systems and to study ways to minimize the risk of supply disruptions caused by what they term "techno-terrorism." This is just another fancy word for guerrilla warfare.

The Energy Department has prepared a report to be used by the different energy-related industries and it showed that the electrical power grids were the most vulnerable. They even tried to impress the industry that cutting off our power would disrupt the electronic networks within the nation's banks! Now that ought to get everybody's attention! Our government is telling us that our great central banking system is the bedrock of our liberty, freedom and security!

## **Assault Weapons**

The official Department of Defense definition of an assault weapon is one that will fire either in the fully automatic mode (by which the weapon continues to discharge bullets in rapid succession as long as the trigger is depressed), or, by turning a selector control, will fire in the semi-automatic mode, by which the weapon will discharge one bullet for each press of the trigger.

Generally, a weapon, fired in the fully automatic mode is not very accurate. In comprehensive tests, it is only the first bullet that leaves a fully automatic weapon that can be, with any assurance, considered accurate. On the other hand, the semi-automatic weapon can be aimed very quickly between trigger squeezes; therefore, it is by far the more deadly weapon. Consequently, when a guerrilla force, or a population in rebellion, is in the field without a large arsenal for the supply of ammunition, the semiautomatic is more effective by a factor of ten.

The forgoing discussion is the real reason why, Mr. Metzenbaum in the Senate, and Mr. Berman in the House, are pushing for what they have termed "assault weapons" to be outlawed. They are wanting not only to stop the sale of such weapons but they are demanding that such weapons already in the hands of American citizens be confiscated.

It isn't the loss of power to the electronic funds transfer of the Central Bank that is the great danger to our freedom, liberty and security. These two bills, being pushed by these two "Johnny come-latelys" to the American heritage, are the real threat to our security.

The whole argument being orchestrated throughout the nation on talk shows, the news media, and even in churches, is not over our right to "go deer hunting with an assault rifle." It is our inalienable God-ordained right to defend our life, liberty and property from whatever is the threat. That threat can be so-called "terrorists" from without or from within our country.

As late as 1939, the United States Supreme Court, drawing from Constitutional and historical documents, interpreted the original intent of the word "militia" as to mean one comprised of "all males physically capable of acting in concert for the common defense (of the people, not the government -ed.), and further, that ordinarily when called for service these men were expected to appear bearing arms supplied by themselves and of the kind in common usage at the time." In common usage today is the semi-automatic rifle that holds thirty or more rounds in a bottom loading clip and may, or may not, have a folding stock!

The second amendment rights, is not to give us the "license" to go deer hunting. The second amendment gives us not the right but the duty, to defend our life, liberty, property and pursuit of happiness from a government that has turned despotic.

When these two men, and there are many others, self-styled experts in our Christian Republic heritage figure out that the old "battle-field" weapons could very easily be more of a threat to their plans than even the "assault weapons", they will want to outlaw and confiscate those too. Make no mistake about this.

The "battle-field" weapon of World War II uses the 30-06 and .308 caliber cartridge. These are accurate to 800-1000 yards whereas the assault weapons are generally accurate to 200-300 yards. The 30-06 type rifles are generally the ordinary "old-fashioned" deer hunting rifle. They don't care a hoot about the assault weapon in particular. They want ALL weapons. History will show us, without one single exception, that when the citizen is disarmed, the nation's freedom is lost. The ONE thing that all governments of the world understand and that is that power and freedom come out of the barrel of a gun.

God knows that abortion is murder. There have been 12-15 million murders of unborn babies in the past 10 years or so and that is an abomination to God, no matter how it is rationalized.

But this point must be made crystal clear to all freedom loving Americans everywhere. Since the start of this century, all countries of the world whose governments have disarmed their citizens, have murdered hundreds of times more people than the abortion mills have. Those little babies in their mother's wombs couldn't defend themselves. But we Americans with the heritage and blood of our forefathers who hacked, sweated, fought, bled and died to build this great republic can, and must.

## **Our Trip to the Congressmen**

It is not intended in this article to give a total review of the recent visit to selected congressmen in Washington by seven of us ministers and elders. That has been accomplished very accurately and professionally. We do, however, want to present that part of our discussions with them as it pertains to the preceding articles.

The main thrust of our presentations and the brochure that was handed to them was centered around the *Remnant Resolves* and *Our Forefathers Resolves to King George III* which included, "Declaration And Resolves Of The First Continental Congress, October 14, 1774"; "Fairfax County Resolutions"; "Resolves Adopted In Charlotte Town, Mecklenburg County, North Carolina, May 31, 1775"; and "Declaration Of The Causes And Necessity Of Taking Up Arms, July 6, 1775". Both the current *Remnant Resolves* and *Our Forefathers Resolves* are in booklet form and are available.

In our discussions, we presented to them the, concept that our beloved Christian Republic has fallen into many of the same conditions that our forefathers realized and attempted, peaceably, to resolve with King George. We showed them current conditions that are nearly identical to those times, with examples, and we were prepared to discuss them in detail. The topics for discussion that we had listed were: Indiscriminate immigration, Protection of AIDS victims contrary to Bible Law, World Conservation Bank, Disregard for private property rights and the relationship to the World Conservation Bank, Police state caused by the indiscriminate immigration, Total subservience to Israeli, Free Trade Zone (Internationalism versus Nationalism), Foreign Aid, BATF arrogance and gun control measures, Government connection with drugs (BoGritz) and Terrorism and lack of communication with the public.

History tells us that our forefathers didn't impress King George III one little bit (Our lessons in history explain why). History also tells us that our Christian forefathers had to resort to the Declaration of Independence. For the purpose of relating the above topics to current conditions, it is expedient to take excerpts from the Declaration Of Independence. Most of us love that document but how many of us have read it with the thought of relating it to modern United States of America?

### **Excerpts of the [Declaration Of Independence](#) Unanimously adopted by the Continental Congress, July 4, 1776.**

"When, in the course of human events, it becomes necessary for one people to dissolve the political bands which have connected them with another, and to assume among the powers of the earth, the separate and equal station to which the Laws of **Nature and of Nature's God** entitles them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed. That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shown, that mankind are more disposed to suffer, while evils are sufferable, than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object

evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security. Such has been the patient sufferance of these Colonies; and such is now the necessity, which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world...

"He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their public Records, for the sole purpose of fatiguing them into compliance with his measures. (United Nations, Regional government and Council of Governments)

"He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasion on the right of the people. (Federal intrusion into the responsibilities of the States and Counties. Just one example is that of education)...

"He has endeavored to prevent the population of these States; for that purpose obstructing the Laws of Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands. (Indiscriminate Immigration contrary to the national concept of this country as written in laws by our forefathers.)...

"He has made Judges dependent on his Will alone, for the tenure of their offices, and the amount and payment of their salaries. (Federal judicial intervention in cases ranging from the speed limit on highways to murder.)

"He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our people, and eat out their substance. (IRS, OSHA, etc.)...

"He has affected to render the Military independence of and superior to the Civil power. (FEMA and its command over the military when ordered by Executive Order, forming into one National Police Force, SWAT teams, Border Patrol, Customs Officers, DEA, FBI, Forest Service, Bureau of Land Management, State Game Departments, etc.)

"He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation (The Genocide Treaty, The International Monetary Fund, The Basel Bank of Settlements, The Council of Foreign Relations, The Trilateralists, The Bilderbergers, The Club of Rome, The Round Table, etc.):...

"For depriving us in many cases of the benefits of Trial by jury (The actions of the Office of Special Investigations within the Justice Department):

"For transporting us beyond Seas to be tried for pretended offenses ( Artukovic, John Demjanjuk, Karl Linas, etc.):

"For taking away our charters (Christian), abolishing our most valuable Laws, and altering fundamentally the Forms of our government (Republican):...

"He has excited domestic insurrections amongst us, and has endeavored to bring on the inhabitants of our frontiers, the merciless Indian Savages, whose known rule of warfare, is an undistinguished destruction of all ages, sexes and conditions (The indiscriminate immigration and the untold number of domestic disturbances this has caused, the open acts of terrorism and guerrilla warfare that this open immigration has caused, the controlled watters riots of Los Angeles resulting in the federal martial law concepts of the Garden Plot,

Cablesplicer and Rex 84 programs):" ....Yes, we have been a people disposed to suffer, while evils are sufferable...

## A Lesson in History Part 2 – The CABAL

In the [January-February issue](#) of the INTELLIGENCE NEWSLETTER, the first of a series of historical articles was presented. The purpose of these is to show the important incidents in history that materially affected the national heritage of our people, our customs and mores, and even the understanding of our Christian faith. These reviews are to be written from the perspectives of both the victors and the vanquished.

The "government" above the governments, not only in the United States, but in all of the western Christian nations was developed as a direct result of the incidents in history that will be presented. When we study out of the average history book it is difficult to relate a single incident discussed in that particular book to incidents found in other writings. Does a pattern evolve out of all of these incidents? Are the people involved in the incidents related to each other in any way? We will find, as we continue in our studies, that there is a pattern and there are relationships among the peoples involved.

The response from you readers to the [first lesson in history](#) has been very gratifying. It has already been suggested that the series, when it is completed, be published in a book form. We will decide on that later. We at CHRISTIAN CRUSADE FOR TRUTH thank you for your support and confidence. We pray daily that we are worthy.

It was stated in the [last issue](#) that we must write much more about the incidents that occurred in England in the 16th, 17th, 18th, and 19th centuries if we are to understand the World Revolutionary Movement (WRM). Over this comparatively short period of time, the forces of evil were developed that have culminated in this maddening drive toward One World Government.

Behind those forces, in our modern Mystery Babylon, was the development of the Bank of England. The creation of money out of nothing, fractional reserve banking and the direct taxation of the people for the payment of national debts to the Central Banks, all of which are privately owned, is the great hammer held over our heads.

For all of this to happen, it was necessary that our Christian doctrines be modified. In the [last issue](#), it was shown that John Calvin was the first to teach that usury (loaning money at interest) was acceptable in Christian doctrine.

Why was England chosen as the place where Christian doctrine was to be modified? Because it was from England and Germany, not Rome, that Christianity became the compelling force to lead the world. Germany will be covered in detail in future issues.

Here are some quotes from early church fathers and historians that will show the importance of Christianity that once existed in England:

Tertullian (A.D.155-222) wrote, "The extremities of Spain, the various parts of Gaul (Galatia-ed.), the regions of Britain which have never been penetrated by Roman arms have received the religion of Christ." (*Tertullian De.Fidei*, p.179)

Eusebius (A.D. 260-340) wrote, "The Apostle (Paul) passed beyond the ocean to the Isles called the Britannic Isles:" (*De Demonstratione Evangelic, Lib.111*)

Dorotheus, Bishop of Tyre, A.D. 303 wrote, "Aristobulus, whom Paul saluted, writing to the Romans ([Romans ch. 16:10](#)) was Bishop of Britain." (*Synopsis de Apostol. Synops 23 Aristobulus*)

Gildas, (Albanicus) the Wise (A.D. 425-512), the early British historian wrote, "Christ, the true Sun afford His light, the knowledge of His precepts, to our Island in the last year, as we know, of Tiberius Caesar." This was in A.D. 37, four years after the crucifixion. (*De Excidio Britanniae*, Sec. 8, p.25)

Augustine, writing in A.D.600 said, "In the Western confines of Britain, there is a certain royal island of large extent, surrounded by water, abounding in all the beauties of nature and necessities of life. In it the first neophytes of catholic (universal) law, God beforehand acquainting them, found a church constructed by no human art, but by the hands of Christ himself, for the salvation of His people." (Spehnan, *Conecilia*, p.5)

William of Malmesbury (1080-1143) was asked by the monks of Glastonbury to write their history. He said that after the Crucifixion, Joseph of Aramathea arrived with 11 missionaries and that the king gave them 12 Hides of land. (*De Antiquitate Glastoniae* Chap.1)

Maelgwyn of Llandaff in A.D. 450 wrote these words, "Joseph of Aramathea, the noble decurion, entered his perpetual sleep with his 11 companions in the Isle of Avalon." (Cottonian M.S. and *Usher, Antiquities*, P.12.

Polydore Vergil, the Italian historian (1470-1555), wrote, "Britain, partly through Joseph of Aramathea...was of all kingdoms the first that received the Gospel." (Lib.1I)

Now you can realize that it was for a purpose that Thomas Cromwell destroyed the church at Glastonbury as well as many others that were a part of that early Christian movement called "The Way."

The great battles that took place between the Roman Empire (which was totally controlled by the great "Synagogue of Satan") and Christianity in Britain as well as the great empire of the Franks will be discussed in later issues. But first, back to the England of the 17th century.

## The CABAL under King Charles II

The word "cabal", as used by the English people at the time of Charles II, came from the French word *caballe*, which meant any group of political or private intriguers. The French acquired the word from the Jewish Talmudic community and they, in turn, acquired it from the word *Kaballah*, which is the representation of theology in terms of esoteric occultism.

The English people very accurately used the word "cabal" to describe the group of political intriguers who worked in the court of King Charles II. It was during this time in English history that great forward strides were being made in the "marriage" of the families of the international money barons and the English nobility. There was much, much intrigue going on behind the scenes, theoretically out of the sight of the English people, that has materially changed the way of life today for nearly every person on the face of the earth.

The English people did one thing more with their word "cabal". The letters making up the word, C,A,B,A and L, represent the first letter of the name of the person in the group of intriguers. The names of the men were: **C**lifford, **A**rlington, **B**uckingham, **A**shley Cooper, and **L**auderdale.

Not all of the men involved in the cabal cabinet under Charles II were influential. Clifford, Arlington and Buckingham were not very important in the course of this portion of history. It was Ashley Cooper and Lauderdale and their descendants who were instrumental in making great changes in Christian theology and in our customs and mores.

The one significant thing that the cabal did was to foment strife between the Anglican Church of England, the other Protestant denominations and the Roman Catholic Church. The one person who was a zealot about this was Ashley Cooper. He was a born agitator and demagogue. He was a forerunner of the modern party leader. He was termed a "free thinker" by the people around him. Once, when asked by a lady what his religion was, he replied: "The religion of all wise men." When she persisted further, and asked what that was, he answered: "Wise men never tell." Ashley Cooper became the first Earl of Shaftsbury. This family name and this title will come down through history as important in the formation of what is now known as Judeo-Christianity. [1](#)

The other name in the infamous cabal is Lauderdale. The name is actually from the title "Duke of Lauderdale." His actual name was John Maitland (1616-1682). The following biographical sketch comes from the "William Murray, a native of Dysart, a seaport in Scotland, was made Earl of Dysart in 1643, and his eldest child and heir, a daughter Elizabeth, obtained in 1670 a re-grant of the title and first married Sir Lionel Tollemache but he died ...She married secondly John Maitland the 1st Duke of Lauderdale. This Countess of Dysart (afterwards Duchess of Lauderdale) was a famous beauty of the period, and notorious both for her amours and for her political influence. She was said to have been the mistress of **Oliver Cromwell**, and also of Lauderdale (John Maitland) before her first husband's death and was a leader at the court of Charles II..." [2](#)

So we are beginning to see that it was "all in the family!" The names that we want to keep in mind as we continue with this history are **Maitland** and **Ashley Cooper**.

Martin Luther wanted only to remove the heresies that were a part of the Roman Catholic Church. Most reputable histories of the Christian faith written by both Christians and Jews show that Christianity was infiltrated and influenced by Jews for the purpose of "reforming" Christianity to bring it back into conformity with Jewry. The term used was "judaizing". Martin Luther wanted to remove these heresies.

We have recently obtained for our library a most revealing book titled *Jewish Influence On Christian Reform Movements* by Dr. Louis Israel Newman, published by Columbia University Press in 1925. This book, written by a notable Jewish historian, confirms the many other books on the subject.

In 1585, a Spanish Jesuit priest named Francisco De Ribera wrote a commentary on the Book of Revelation, the last book of the Bible. He did this in direct contradiction to the teachings of Martin Luther. The Jesuit order had also been infiltrated. Nearly one-half of the German Catholic church left with Luther. The church at Glastonbury, which was described earlier in this issue, had once again become the leader of Christianity in England. Christianity was moving rapidly back to the theology of "The Way."

The Jesuit Ribera taught in his commentary that:

1. The Anti-Christ was a political ruler, one person, who was yet to appear.
2. This ruler would rebuild the temple in Jerusalem, restore animal sacrifices for the Jews and rule for three and one-half years.
3. That he would rise to power in the last days and make a covenant with the Jews.

The Christian community was strong enough at that time to withstand this teaching. Consequently, the theory went into obscurity until 1838. A Dr. Samuel Roffey Maitland, who was the Archbishop of Canterbury in England, "found" the treatise written nearly 300 years earlier by the Jesuit Francisco De Ribera.

So our first name, Maitland, shows up again in English history. At first, this may not seem important but when we look across the spectrum of political, financial, religious and governmental affairs, we will always see family names that remain prominent in their respective areas. When these families believe that they have a God-ordained mandate to control the lives of everyone else, we have the making of a conspiracy. When these different families "network" together by helping each other in their specialties and all of them think they have a God-ordained mandate to control the lives of everyone else, we then know that we have a conspiracy.

The same concept is true with organizations. In the course of our studies in history, we will be discussing several prominent organizations that are a part of these family "networks".

To bring the Maitland story and the singular antichrist story into modern times, we must first bring into the "network" another name, Mr. **John Darby** (1800-1882). He became an Anglican priest in England and therefore was at least an acquaintance of Samuel Maitland, the librarian at Canterbury. Mr. Darby was also a [Freemason](#). This organization will not be discussed in this issue; however, we will show in future issues that the world Freemasonry movement can rightfully be called the "battleaxe" of the World Revolutionary Movement (WRM). Although the great majority of Masons do not know, or will not admit, of this involvement, the unquestioned historical facts prove culpability at the highest level.



**John Darby**

Mr. John Darby became involved with the formation of an organization in England called The Plymouth Brethren. The librarian, Samuel Maitland, gave the Jesuit priest's commentary on the singular antichrist to Darby. It was John Darby who took the concept and preached it from the bottom of his lungs. It was here, in the United States that the idea caught on and it was here, in this country, where Darby received a lot of help in getting the idea accepted.

We now can add to this story coming down in history from families who were involved in the CABAL under Charles II. We are still involved with Maitland. We will show the tremendous involvement of Ashley Cooper shortly!

Another Jesuit priest by the name of Lacunza prepared a treatise on what was termed the **rapture**. This is the theory that Jesus will come twice, first for his saints to "rapture" them to be with him, then the second time for his judgment and rule. Again, this theory was not accepted by the Christian faith, just as the singular antichrist concept was not accepted. However, again, it was Samuel Maitland who took the treatise, rewrote it to make it fit with the singular antichrist concept, and gave it to John Darby.

## **Dispensationalist Premillennialism**

Mr. John Darby, armed with this new found knowledge, developed the concept of **Dispensationalist Premillennialism**. This theory promotes the idea that the Jewish people must return to their homeland before the second advent of Christ can occur. Darby

then married the dispensationalist theory with the singular antichrist and rapture theories by stating that there would be the judging of all nations as well as the Jews during a great and terrible tribulation for three and one-half years. During this time, according to him, there would be 144,000 Jews who would be converted to Christianity and then, after the tribulation, those Christians who were "raptured" before the tribulation took place would return to earth and then Jesus and the 144,000 Jews would rule all of the nations for the millennium.

The period 1830-1850 was rampant with organizations which were extremely active in judaizing Christianity and these organizations became politically active in seeking to create a nation in the Mideast in which all of the Jews of the world could settle. It should become obvious that the Plutocratic "marriage" arrangement between the international money barons and English new-found nobility, using the World Revolutionary Movement, was behind all of this.

In 1844 the Christadelphians were established in England by John Thomas, author of *Elpis Israel*. From the outset, this sect supported the return of Jews to the "Land of Israel". Later it offered practical assistance to Jews, such as support of the Hibbat Zion movement, an early Zionist group.

Mormons, founded by Joseph Smith (32 degree Freemason) in the United States in 1830, held that Jews would return to their land as "a sign of the time" of the second coming. In 1841 the Mormon missionary Orson Hyde was sent to Jerusalem, where he recited a "Zionist" prayer and dedicated the land to the Jews from the top of the Mount of Olives in Jerusalem.

The Adventist movement, which emerged in the United States in 1830 split into many sects. They believe that the return of the Jews to the "Land of Israel" as a fulfillment of their eschatological beliefs and some of them have moved their centers to Israeli. [3](#)

"At the beginning of the 19th century, England experienced an evangelical revival whose dogmas and beliefs were very similar to those of 17th century Puritanism. Christopher Sykes calls this revival 'the second spring of the Puritan genius' ....

"This new era of evangelism lasted roughly until the end of Queen Victoria's reign (1837-1901). Typical of the long list of Victorian Christians advocating Jewish Restoration for messianic or more practical considerations, were Edward Bickersteth and Lewis Way, both members of the London Society for Promoting Christianity among the Jews, founded in 1807. But by far the most well known and influential evangelical was **Lord Antony Ashley Cooper, seventh Earl of Shaftsbury** (1801-1885), the 'Evangelical of all the Evangelicals' and a central figure in the tradition of non-Jewish Zionism...

"Shaftsbury constant preoccupation with the Jews' return to Palestine as a nation made him the chief advocate of such a plan long before it gained currency with the British and imperial establishment. He was convinced, much more than the Puritans had ever been, that human instrumentality could bring about divine purposes - a principle still unacceptable to the majority of Jews at that time...

"Although Lord Shaftsbury was by far the most outstanding of all the 19th Century Evangelicals drawn to the cause of the Jewish Restoration, there were many others of stature and influence who laboured to achieve this goal. There were members of the British nobility, led by the Duke of Kent and many members of the House of Lords, such as the Earl of Crawford and Lindsay, the Earl of Grosvenor, Lord Gray, and Lord Bexley". So there is the connection with the other family mentioned in the CABAL of Charles II. Ashley Cooper, the seventh Earl of Shaftsbury, was continuing with the same zeal as his ancestor, 200 years earlier.

"The most famous of the Zionist Millenarians in the United States was William Blackstone (1841-1933) of Chicago, the author of *JESUS IS COMING*, in which he expounded his belief in the future of the Jews in the land of Israel according to the Dispensationalist concept. He attempted a political realization of his ideas through memoranda to the president of the United States, in 1891 and in 1916, which demanded American intervention for the return of the Jews to the land of Israel as a solution to the Czarist anti-Jewish persecutions." **C.I. Scofield**

Mr. Blackstone was a personal friend to two other famous Zionists, C.I. Scofield and Samuel Untermyer. Scofield, of course, was the editor of the well known *Scofield Bible*, which is based on Dispensationalist concepts. It was Mr. Samuel Untermyer who blackmailed President Woodrow Wilson, because of some of Wilson's undisclosed indiscretions, into naming Louis Brandeis as Supreme Court Justice.

The Evangelicals, both in England and here in the United States, were not alone in the accomplishment of this phenomena. But it was an absolute must that Christian doctrine had to be modified before politicians and the statesmen could act without remonstrations from the public. In other words, the people of the Christian nations of England and the United States had to be put to sleep with a totally emasculated theology. Then, and only then, could the World Revolutionary Movement of Plutocratic, Elite Capitalist, Zionist England move forward in its drive for world dominion. That movement is not only still alive and well but it is getting stronger. The Anglophile leadership in the U.S. is right where "Perfidious Albion" wants them.

The "World Empire" envisioned in the middle of the 19th century was, of course, different from what it is today. Then, it was to be done through colonialization, which was very necessary and effective. It provided training, organizational concepts and, most important, the development and installation of the central banks. These banks, of course, are simply extensions of the Bank of England. That includes the Federal Reserve Bank of the United States. It is no more "federal" than the Federal Express Corporation, nor is it American.

But in the middle of the 19th century, it was "empire through colonialization." With respect to the plutocrats of England and their thoughts regarding world Jewry and Palestine, in 1845, Mr. Edward L. Mitford of the Colonial Office in London wrote *An Appeal On Behalf Of The Jewish Nation In Connection With British Policy In The Levant*. (The Levant is the term used to define those regions in the Mideast including, the eastern Mediterranean and the Aegean, from Greece to Egypt, including Syria, Lebanon, and Palestine.)

"The plan I would propose is, first, the establishment of the Jewish nation in Palestine, as a protected state, under the guardianship of Great Britain ...Secondly, their final establishment, as an independent state, whensoever the parent institutions shall have acquired sufficient force and vigour to allow of this tutelage being withdrawn..." [6](#)

"Among the 'incalculable advantages', economic and strategic ones were primary. A Jewish state would place the 'management of our steam communication entirely in our

hands and would place us in a commanding position in the Levant from whence to check the process of encroachment, to overawe our enemies and, if necessary repel their advance.' [Z](#)

"The advent of steam navigation during the 1840's also made the Near East important for British control over the route to India. Steamships required frequent re-coaling and therefore British ships used the Mediterranean Red Sea route with transshipment at Suez, rather than the long Cape route.

"Mitford also shared the other Zionists' positive biases toward the Jews. He described them as a far superior people, incorporating the peculiar qualities of fortitude and perseverance which made them deserving of an independent state of their own in Palestine. But he also had the foresight to raise the problem of Palestine's own Arab population: [8](#)

"The country, compared with its extent, is at present thinly populated, yet the pressure caused by the introduction of so large a body of strangers upon the actual inhabitants might be attended with injurious results. Before, however, attempting to make a settlement, it would be desirable that the country should be prepared for their reception. This might be done by inducing the Turkish government to make the Mohammedan inhabitants fall back upon the extensive and partially cultivated countries of Asia Minor..." [9](#)

This should be sufficient evidence to show that there was indeed a conspiracy and it was for the purpose of building a world empire. The colonial concept is now gone because it is not needed. It is true, Russia is trying the colonial concept but they are nearly 300 years behind the times. Training, organization, and international money has replaced that need. In addition, modern weaponry and communications have made the world smaller. The concept now is, instead of owning colonies all over the world, to entice large numbers of the populations of the third world countries to move to the industrialized nations. This is being done even over the opposition of the people of the host industrialized nation.

The multi-national corporations have moved their operations into these third world countries. Thus, these corporations have a labor force at a reduced rate of pay. They take some of the more qualified natives from these third world countries who have moved into the industrialized countries back to their home country to act as the cadre to train the natives. The rate of pay in these third world countries is appallingly low. As an example, in the Twin Plant concept, or *Maquiladora* program, in Mexico, the pay scale is twenty-five cents per hour.

No, we don't need colonization anymore. The Plutocratic, Elite-Capitalist, Bolshevik, Zionist one world system now has the whole world as their colony.

The "conflict" between the Plutocratic forces and the Soviet "colonialization" concept is a perfect example of Hegelian Dialectics in action. The Plutocratic, Elite-Capitalist, Bolshevik, Zionist system, controlled by the World Revolutionary Movement centered in England, organized and funded the Bolshevik Revolution of Russia in 1917. The Plutocrats funded and supported the Soviets in their drive for colonialization. During this same period of time, the Plutocrats disbanded their colonies and preached to the world "self-determination." They even helped the Soviets take over some of their ex colonies with the African countries and Vietnam as good examples. Thus, the dialectics is in place. All we hear now is, "How terrible colonialization is" and "self-determination."

Why is it so important to the United States to be so protective of Palestine? It is for the same reason that it was for the British in 1850, to keep the "steam navigation" open for the "British East Indies Company". Now it is called GE, IBM, RCA, RJR Nabisco, Caterpillar, John Deere, etc.

Before the Federal Reserve Central Bank was forced on the United States in 1913, we were Nationalist in our concept as a nation of people. We produced what we used and the pride of our workmanship was reflected in the quality of our products.

The fight for the central bank concept in the United States will be presented in another issue.
