Pool Repair Project – Concrete has been completed. The pool needs to be waterblasted, plastered, painted and filled. Fencing will be installed prior to the pool being filled.

Concrete Replacement – Steve Elmore and Les Gurtler determined that no other stoops need to be replaced. The money for the stoops will be used for sidewalk replacement.

Carpet Cleaning – The contractor cleaning the carpet missed building 300 and 600 and will return to finish those buildings.

Green Electric – Work to replace the exterior building and parking lot light fixtures with LED is 50% complete.

Census Cards/Fines – Will be discussed during Executive Session.

Guardian Racoon Trapping – Management will post notices to remind residents to close the garbage can lids. Steve Elmore will check into getting new garbage cans.

INSPECTION REPORT – Steve Elmore reviewed the inspection report with the Board.

Garage Doors – Steve Elmore will do an inspection of the garage doors and take pictures of those in poor condition. Steve will get bids for those that need to be painted.

Landscape – The Board discussed ways to remove the rotted timbers in front of the gas meters.
