Experiencing issues with telemetry between water plant and wells - it seems to be a problem on the phone line on the return signal. AN ORDINANCE TO ANNEX CERTAIN TERRITORY AND TO INCORPORATE THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF ROLLA, COUNTY OF ROLETTE, STATE OF NORTH DAKOTA. PURSUANT TO THE PROVISIONS OF NDCC 40-51.2

PREAMBLE

An Annexation Resolution was adopted by the City Council of the City of Rolla on September 7, 2016 resolving to annex the property described in the Resolution to the City of Rolla.

The annexation of such territory is deemed necessary for the welfare of the residents and property owners thereof and of this city as a whole.

NOW THEREFORE, BE IT ORDAINED, by the City Council of the City of Rolla, County of Rolette, State of North Dakota as follows:

Section One

There is hereby annexed to the City of Rolla, County of Rolette, State of North Dakota, and incorporated within the corporate boundaries thereof, the following territory adjoin the present corporate boundaries of the City:

BE IT HEREBY RESOLVED that the City of Rolla annex the following described real estate:

A plat in Outlot "P", a parcel of land located within the "Keegan-Neameyer Plat" within the Northeast Quarter of the Southeast Quarter(NE1/4SE1/4) of Section Seventeen(17), Township One Hundred Sixty-two(162), Range Sixty-nine (69) West of the Fifth Principal Meridian, Rolette County, North Dakota. Said parcel contains 5.53 acres, more or less.

The described property is shown on the Plat of Public Service Subdivision which is attached hereto and incorporated by reference into this Resolution.

Section 2

The corporate limits of the City of Rolla are hereby extended and increased so as to include and embrace within the corporate limits of the City of Rolla, the territory described in Section One hereof, and such territory is hereby declared to be a part of the City of Rolla.

Section 3

The map attached to this ordinance is an accurate map of the territory annexed, and the Mayor of the City of Rolla, is hereby authorized and directed to certify that the map is an accurate map of the territory annexed under the provisions of this ordinance, and to record in the Office of the Register of Deeds this Ordinance together with a certified copy of the official map attached hereto.

This ordinance shall take effect immediately after its final passage, the public welfare require it.
