I agree to and understand the following:

- Vendor must only display and sell what has been described above.
- Be prepared for the weather and aware of potential windy situations.
- Each vendor must provide own canopy/shade cover, tables, chairs, cash box and any other related items needed to sell merchandise.
- Each vendor space will be no more than 10' square.
- Vendor fee is \$35 per person of \$70 per group.
- Vendor must set-up, take down and remove all trash from their vendor location
- Vendor must be set up no later than 9:00 a.m. and parked in a designated vendor parking spot. Set up time begins at 7 am. Early setup available May 17 by prearrangement.
- Tear down no later than 5:30 p.m. day of event.
- If applicable, vendor shall be responsible for procuring any necessary license or official permits for the purpose of this event.
- Vendor is responsible for own liability and property insurance; collecting and reporting sales tax on his/her sales.
- Due to the safety of guests, no pets or are permitted on the property.
- No smoking is permitted on the property.
- By acceptance of this agreement, the vendor expressly releases Dorland Mountain Arts Colony, their agents, directors, officers and employees from any liability for any damage, injury, or loss to any person or goods which may arise from the display and sale of items.
- Vendor releases the Dorland Mountain Arts Colony, Inc. from any and all liability for the failure to fulfill this agreement due to any Act of God, fire, the authority of the law, or any other cause beyond the control of Dorland. Dorland's sole obligation to the vendor due to cancellation of the event shall be to refund vendor's application fee.
