

SCHOOL ATTENDANCE

School attendance is mandatory for all enrolled students. The school day begins at 8:00 am. If a student is going to be late or absent, the student's parent/guardian is asked to call 849-3229, or provide a written, signed excuse which the student will present upon arrival to school. Students are to report to the Main Office and Guidance Office to sign in when arriving late to school. **To participate in a co-curricular activity, a student must be in school and on time the entire day, beginning at 8:00 a.m.**

ACCIDENTS

If you are involved in an accident that occurs on school premises, go to the Nurse's office. If the nurse is unavailable, report the accident to your coach, advisor, teacher or other adult and/or administrator.

STUDENT MEDICATIONS

All medication shall be stored and administered by the school nurse. Parental permission must be filed with the Nurse's office. The items must be brought to school in the original container with the label intact and legible. The school nurse may administer the items if the parent submits a written request accompanied by the physician's statement indicating the frequency and dosage.

MEDICAL EXCUSES

Students with a doctor's statement to be excused from Physical Education must file this excuse with the nurse. The nurse will send a copy to the Physical Education teacher and another to the Guidance Counselor. The original excuse will be placed in the student's health record. The student is to notify the Physical Education teacher that the nurse has the note.

TRANSPORTATION

District transportation is provided for students to get to and from school. Bus drivers do not allow students to get on or off the bus anywhere except their regularly scheduled bus stop. Only students assigned a bus route may ride a bus, including the late bus. Any student wanting to ride a bus route that is not their own must have written permission from their parent/guardian. This note must be handed into the Main Office in the morning. The student will pick up the bus note at the end of the day.

STAYING AFTER SCHOOL

There is a late bus at 4:10pm Tuesday and Thursday for those students who need to stay after school. The student must sign up for the late bus with the teacher they are staying after school with for that day.

STUDENT DRESS CODE

All students are expected to give proper attention to personal cleanliness and to dress appropriately. Students and their parents have the primary responsibility for acceptable student dress and appearance. (*See Dress Code Appendix for pictures*)

Student dress must:

- Not include garments such as tube tops, halter tops, midriffs, spaghetti straps, plunging necklines (back and front), short skirts, short shorts, any see-through garments or other such items deemed inappropriate.
- Ensure that undergarments are completely covered with outer clothing.
- Include footwear at all times. Footwear that is a safety hazard will not be allowed.
- Not bear an expression, picture or insignia that is vulgar, obscene, or libelous or that denigrates any individual or group based upon race, sex, color, sexual orientation, religion, ancestry, or disability.
- Not promote or endorse the use of alcohol, tobacco, or illegal drugs and/or encourage other illegal or violent activities.
- Not be comprised of any article or item that could be used as a weapon or that has no reasonable purpose in a school.
- Not display words or pictures that offer a double meaning that may be sexual or offensive in nature.

Hats, Coats and Backpacks

Hats, coats and backpacks are to be stored in student lockers. No hats, coats or backpacks will be allowed in classrooms, hallways, the cafeteria, or any offices or other areas. This includes hoods and any other headgear.

Extracurricular Activities

It should be understood that students who participate in any extracurricular activities may be asked to meet a higher expectation regarding their dress. When in a position of representing the school district and the community as an ambassador, these students have an additional responsibility to meet guidelines for dress as prescribed by their advisor, coach, chaperones, or Building Principal.

Each Building Principal shall be responsible for informing all students and their parents of the student dress code at the beginning of the year and any revisions to the dress code made during the school year.

Students who violate the dress code shall be required to modify their appearance by covering or removing the offending item, and if necessary or practical, by replacing the item. Any student who refuses to do as instructed or who fails to comply shall be subject to discipline, including suspension from school.

EXTRACURRICULAR ACTIVITIES CODE OF CONDUCT

A full detailed version of this policy can be found in the Student Handbook/Code of Conduct.

Definition: Extra-curricular is defined as an official school sponsored activity that is outside the prescribed curriculum.

Examples of extra-curricular activities include but are not limited to:

Clubs/organizations (IE. Drama, FBLA, Student Council, Marching Band, etc.)
School sponsored athletic teams (Any sport)
Attendance at school related function after hours (IE. sporting events, concerts, plays, etc.)
School dance (IE. school dances & formal dances)

Why have a code of conduct for JSHS extra-curricular activities?

Participation in all extra-curricular activities is a privilege that demands responsibility.

What are the requirements of the code?

The code has three (3) components.
All three components weigh equally, and all three components must be achieved in order to earn eligibility for any extra-curricular activity.

Academics

Not failing 2 or more courses in a 5-week segment

Attendance:

Be in school on time the day of an activity AND have a 90% daily attendance rate.

Citizenship:

Demonstrate respect to all. Discipline referrals can impact eligibility.

What if one (or more) of the components to the code is not achieved?

If during any 5-week segment of the school year, a component(s) is not achieved, an administrator will notify the student about what component(s) was (were) not achieved. This student will be put on *probation* for the next 5-week segment.

The student on *probation* must attend mandatory study tables, but is still eligible to participate in an extra-curricular activity for this time period. At the end of the 5-week segment, if a student has yet to meet the required three components, then he/she will become *ineligible* for participation in *any* extracurricular activities for the next 5-week segment.

Administration/Guidance will be in charge of notifying all students, parents, teachers, and advisers/coaches of code infractions, ineligibility, and eligibility for students.

TOBACCO POSSESSION

No student is permitted to possess tobacco of any kind or tobacco related paraphernalia on school property, grounds, or at a school-sponsored event or activity off campus.

SCHOOL FOOD SERVICE

Breakfast and lunch are available at school for students daily. For the 2018-19 school year, breakfast and lunch are FREE for all students in grades 7-12. (**Breakfast is served from 7:10am-8:10 am daily**).

Breakfast and lunch menus are posted on the school's website (www.marathonschools.org). If students or parents have questions, please see the lunch staff or Mr. Zaryski in the cafeteria.

CLOSED LUNCH

At the junior-senior high school we operate what is called a closed lunch policy. This means that students are scheduled for lunch in the cafeteria and are to report there regardless of whether they are eating. The only exception is if a student has a pre-signed pass to be with another teacher. Students do not have permission to leave the building at this time - they are to report to the cafeteria as they would for any other scheduled class. **Permission is not given for students to eat lunch off campus.**

OVERTOWN POLICY FOR STUDENTS

The following is the procedure to allow twelfth grade students the privilege of leaving the school during the day. Students must have a completed Mandatory Overtown Permission Slip on file in the Main Office in order to follow the below procedure.

1. A student may be released to go over town only when a request is made in writing by one of his/her parents or a guardian. A request may be made in person to the building principal if necessary.
2. Notes must be signed by the Principal and turned into the Guidance Office prior to or during attendance period.
3. Students are to leave for their errands only from study hall.
4. Students are to report to the Guidance Office and Main Office for sign out procedure. The type of errand justifies the time involved over town and it will be left to the discretion of the Principal. If this is misused, future privileges may be refused.
