Bayside Terrace Park Re-Opening!

The Bayside Terrace Civic Club Park is nearing completion and is set to re-open this March! Projects that are scheduled to be completed by Environmental Allies or the City of La Porte include: installation of new park fencing, along with bumpers and parking spot striping, installation of grate over outfall and guardrail around outfall, and rebuilding the park play structure.



Plans for repairing and rebuilding the pier are also underway, with construction to hopefully begin in the 1st quarter of the year.

Bayside Terrace Streets & Drainage Update

The City of La Porte reports the estimated timeline for project completion, is by the end of April 2025. Portions of the project are still under construction on the westside of Bayside along with the neighboring streets of Falk, Layne Ct., Layne Ave. and Humphreville. Installation of water lines should be 95% complete, with installation of storm sewer and paving still needing to be completed on these streets along with Bayside toward South Broadway. After construction is complete there will be a walk thru period where the city will essentially develop a punch list of workmanship issues or defects that need to be addressed.

Construction Advocacy

What a year it has been with all this construction, but there is light at the end of the tunnel, with the project being 70% or more complete. As we draw closer to completion it is very important that we advocate for ourselves with the City of La Porte. Under the contract, the City has the right and the power to hold the contractor to certain standards. Further our Councilman, Jay Martin, has been steadfast in his commitment that we are put back at least as good, if not better than before the construction.

We want to be thorough and be sure the City is aware of any issues. Several residents who had secondary sewer lines, found out their second lines were never connected. This was not the homeowner's responsibility to repair, but Environmental Allies (EA). The city did come out and confirm the problem and lines have been repaired.

Another construction issue occurred on Bonner St., when a crew attempted to "clean up" the street. Rather than clearing the debris and leveling to the curb with clean bank sand, they left all the debris and just scraped dirt from residents own yards to cover cans, bottles, rebar, large chunks of concrete, and pieces of wood. This will cause issues going forward and is not per the terms of the contract.

There have been reports of damaged fences, large tree debris left in yards, large patches of bar dirt with 15 inches of turf (contract calls for 30 inches), problems with yard drainage where there were no issues before, as well as lots that have been used as "unauthorized" staging areas that need to be restored and returfed.

Please be sure to keep thorough records of such issues. The City can only force Environmental Allies to address issues they are aware of, and they only have so long to do so. It's up to you to inform our City. Please report all issues by email to Jameson Appel, Asst. BTCC Current Financial Position

City of La Porte provides support

For the 2024 fiscal year, the BTCC had zero paid members. This was due to the park being under construction as part of the streets and drainage project for the entire year. Our balance of funds stood at \$1,614.00 as of November 30, 2024.

In order to help support the BTCC, the City of La Porte with the help of City Councilman Jay Martin, came to an agreement to support the BTCC for lost revenue for the 2024 fiscal year. In addition, the agreement also included extra funds specifically earmarked to repair and rebuild the pier.

The Bayside Terrace Civic Club held our first meeting for the year on January 14, 2025. Our budgeted expenses for 2025 are projected to be \$4,525.00

Our goal is to have at least 50 members for the upcoming year, or half of the approximately 120 households in our neighborhood to demonstrate our participation to community partners and city leaders. We have 2 board members rolling off the board this year. Returning board members are as follows:
