LDBR RELEASE, WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNIFICATION AGREEMENT

In consideration for your dog(s) being permitted to come to Lucky Dog Barks and Recreation (LDBR), you agree to all of the policies, procedures, release, terms and conditions set forth below.

1. All Dogs must:

- be current on Rabies, Distemper, Flu and Bordetella vaccinations;
- be at least 4 months of age
- be spayed or neutered if 6 months of age or older
- be in general good health and free of ticks and fleas (must be on preventative care for both)
- be non-aggressive towards other dogs and people
- pass the temperament test
- meet all municipal and state license and other requirements
- have a quick release collar that contains an identification tag bearing the Dog's name
- be leashed when entering and exiting the building

2. Food. Dogs will be fed in accordance with the instructions provided in the Application. Since feeding is sometimes adjusted based on your dog's dietary needs please provide us with written feeding instructions at drop-off.
3. Dog Cam and Video Release. By using the services offered by LDBR, you agree to allow us to use your Dog's name and any image or likeness of your Dog taken while at LDB, in any form or format, for use, at any time, in any media, marketing, advertising, illustration or promotional material.
4. Personal Property. LDBR will not be liable for any lost, stolen or damaged personal property belonging either to you or your Dog. If your Dog causes any personal property damage to the building where services are provided, another Dog or otherwise, you will be liable for the full cost of all treatment, repairs and replacements.
5. Fees. You must pay for all services and products by credit card, cash or check. All payment is due at the time you pick up your Dog for services rendered. You give your express permission for LDBR to charge any credit card you provided for unpaid services or products upon the date services were to have been completed. You further agree to pay any cost of any returned/challenged check or debit charges.
6. Cancellation and Refund Policy. You will be charged one (1) full night of boarding, if you fail to cancel your boarding reservation at least forty eight (48) hours in advance of drop off time. Notwithstanding the above, if your boarding reservation is within three (3) days of nationally recognized holiday, you must cancel your reservation within seventy two (72) hours or you will be charged a no-show fee equal to three (3) nights of boarding.
7. Aggressive Dogs. Although we would love all dogs to come to LDBR, your Dog may not be aggressive and must pass our temperament test. Your Dog may be separated from other Dogs or asked not to return to LDBR if he/she exhibits aggressive or other unacceptable behavior. Such determinations will be made at the sole discretion of LDBR.
8. Abandoned Dogs. No Dog may be left after the scheduled pickup time without communication from you. If your Dog is left without any contact, instruction or notification regarding its pickup from you or your authorized representative, your Dog will be deemed "Abandoned" at 7 PM on the seventh (7th) day after the scheduled pickup date. If your Dog is Abandoned, LDBR will become its legal owner and guardian. LDBR will, in its sole discretion, determine whether to rehome the dog or relinquish it to a shelter or rescue of LDBR's choice. **YOU FULLY UNDERSTAND AND AGREE THAT IF YOU ABANDON YOUR DOG AT LDBR, YOU MAY BE UNABLE TO RETRIEVE POSSESSION OF YOUR DOG AND WILL HAVE NO RECOURSE AGAINST LDBR.**
9. Duty to Disclose. You must disclose on a continuing basis, any and all medical or other conditions, including but not limited to personality concerns or behavioral incidents that in LDBR's sole discretion, may affect, limit or prevent your Dog's ability to participate in any LDBR activity.
10. ACCEPTANCE AND ACKNOWLEDGEMENT OF RISK. YOU FULLY UNDERSTAND THAT: (a) THERE ARE INHERENT AND POTENTIAL RISKS INVOLVED WITH INTERACTIONS BETWEEN HUMANS AND DOGS, AS WELL AS BETWEEN DOGS AND OTHER DOGS, WHICH MAY RESULT IN PROPERTY DAMAGE OR BODILY INJURY, INCLUDING BUT NOT LIMITED TO, PERMANENT DISABILITY, SICKNESS OR DEATH TO HUMAN OR DOG; AND (b) THERE MAY BE OTHER RISKS NOT KNOWN TO YOU OR LDBR, NOR READILY FORESEEABLE AT THIS TIME (COLLECTIVELY, "RISKS"). YOU FULLY ACCEPT AND ASSUME ALL RISKS AND RESPONSIBILITY FOR ALL RISKS, INCLUDING, WITHOUT LIMITATION, ALL LOSSES, COSTS AND DAMAGES INCURRED AS A RESULT OF YOUR DOG'S PARTICIPATION, INCLUDING ANY VETERINARIAN EXPENSES INCURRED ON BEHALF OF OR CAUSED BY YOUR DOG. "SICKNESS INCLUDES ANY ILLNESS NOT LIMITED TO BORDETELLA (KENNEL COUGH), BLOAT, OR ANY OTHER FORM OF CONTAGIOUS DISEASE.
11. Veterinarian Liability and Care. LDBR will have the right to obtain medical treatment for your Dog, if, in LDBR's sole discretion, it appears that your Dog may be ill, injured or exhibits any other behavior that would reasonably suggest that your Dog may need medical treatment. LDBR will first attempt to seek treatment from the veterinarian provided in the Dog Application, but will have the right to seek veterinary treatment from an alternative veterinarian if it is unable to reach or transport the Dog to such veterinarian. If a Dog passes away at LDBR, it will be brought to its or nearest veterinarian. **YOU WILL BE FULLY RESPONSIBLE FOR ALL COSTS RELATED TO ANY MEDICAL TREATMENT, INCLUDING WITHOUT LIMITATION, THE COST OF ANY TRANSPORTATION FOR THE PURPOSE OF SUCH TREATMENT.** You must also provide veterinary records to LDBR upon request.
12. WAIVER, RELEASE AND INDEMNIFICATION. YOU HEREBY AGREE TO EXPRESSLY AND FOREVER GENERALLY WAIVE, DISCHARGE CLAIMS, INDEMNIFY, RELEASE FROM LIABILITY, SAVE, HOLD HARMLESS AND DEFEND LDBR, their invitees, owners, officers, directors, employees, contractors, volunteers, agents, representatives, lessors, and all others having an interest in LDBR (collectively, the "Releasees") from and against ANY AND ALL INJURY, LIABILITY, CLAIMS, LITIGATION, ACTIONS, SUITS, COSTS, LOSSES, DAMAGES, ATTORNEY'S FEES, EXPENSES OR DEMANDS OF EVERY CHARACTER WHATSOEVER on account of, arising out of, resulting from or relating in any way to (i) any act or omission of the Releasees, (ii) your Dog's participation at LDBR, services provided. **YOU AGREE THAT THIS RELEASE IS BINDING ON YOU AND YOUR SUCCESSORS, HEIRS, LEGAL REPRESENTATIVES AND ASSIGNS. YOU ALSO EXPRESSLY AND FOREVER RELEASE LDBR FROM ANY DUTY TO PROTECT YOU OR YOUR DOG FROM INJURY OF ANY KIND, AND AGREE THAT ANY IMPLEMENTATION OF SAFETY PRECAUTIONS BY LDBR WILL NOT WAIVE LDBR'S RIGHT TO BE INDEMNIFIED AS PROVIDED HEREUNDER, AND SUCH PRECAUTIONS WILL NOT ALTER THIS RELEASE.**
